HOUSE BILL DRH30256-ML-163 (03/24)

Short Title: Study/MPO Voting Power Distribution. (Public)

Sponsors: Representatives Bradford and Millis (Primary Sponsors).

Referred to:

1 A BILL TO BE ENTITLED
2 AN ACT TO STUDY THE DISTRIBUTION OF VOTING POWER AMONG THE VOTING
3 MEMBERS OF METROPOLITAN PLANNING ORGANIZATIONS.
4 The General Assembly of North Carolina enacts:
5 SECTION 1. The Study Committee on the Distribution of Voting Power in
6 Metropolitan Planning Organizations is created. The Committee shall consist of five members
7 of the House of Representatives, appointed by the Speaker of the House of Representatives, and
8 five members of the Senate, appointed by the President Pro Tempore of the Senate. The
9 Speaker of the House of Representatives and the President Pro Tempore of the Senate shall
10 each designate one member as a cochair. Vacancies to the Committee shall be filled by the
11 same appointing authority making the initial appointment. The Committee shall meet upon the
12 call of the cochairs. A quorum shall be a majority of the Committee members.
13 SECTION 2. The Committee shall study the process used and guidelines followed
14 by Metropolitan Planning Organizations in determining how to distribute voting power among
15 their voting members. The study shall include an examination of other state laws to determine
16 if and how other states regulate the distribution of voting power among the voting members of
17 Metropolitan Planning Organizations.
18 SECTION 3. The Committee, while in the discharge of its official duties, may
19 exercise all powers provided for under G.S. 120-19 and G.S. 120-19.1 through G.S. 120-19.4.
20 The Committee may meet in the Legislative Building or the Legislative Office Building.
21 Members of the Committee shall receive subsistence and travel expenses at the rates set forth in
22 G.S. 120-3.1.
23 The Legislative Services Commission, through the Legislative Services Officer,
24 shall assign professional staff to assist the Committee in its work. The House of
25 Representatives shall assign clerical staff to the Committee, and the expenses relating to the
26 clerical employees shall be borne by the Committee. The Committee may contract for
27 professional, clerical, or consultant services, as provided by G.S. 120-32.02.
28 SECTION 4. The Committee shall report its findings, including any proposed
29 legislation, to the 2018 Regular Session of the 2017 General Assembly. The Committee shall
30 terminate upon filing its final report or upon the convening of the 2018 Regular Session of the
31 2017 General Assembly, whichever is earlier.
32 SECTION 5. This act is effective when it becomes law.
