"TRANSPORTATION FUNDS

SECTION 7.32. Notwithstanding any other provision of law, the funds appropriated from the General Fund to the Department of Public Instruction by this act for the 2017-2019 fiscal biennium for the transportation allotment shall be decreased by the sum of seventy-three million two hundred seventy-seven thousand one hundred ninety-two dollars (\$73,277,192) for the 2017-2018 fiscal year and by the sum of fifty-one million three hundred eighty-six thousand ninety dollars (\$51,386,090) for the 2018-2019 fiscal year."; and

moves to amend the bill on page 114, line 30, by deleting "December 1, 2017," and substituting "March 1, 2018,"; and

on page 114, line 40, by deleting "March 15, 2018," and substituting "March 1, 2018,"; and

on page 114, lines 40-41, by deleting "grants and the vendor selected for the software." and substituting "grants."; and

2 appropriated from the General Fund to the Board of Governors by this act for the 2017-2019
3 fiscal biennium for the UNC Need-Based Financial Aid Program shall be increased by the sum
4 of fifty-three million four hundred eleven thousand six hundred forty-eight dollars
5 (\$53,411,648) for the 2017-2018 fiscal year and by the sum of fifty-one million three hundred
6 eighty-six thousand ninety dollars (\$51,386,090) for the 2018-2019 fiscal year.
7 **SECTION 10.22.(b)** Notwithstanding any other provision of law, the management
8 flexibility reduction for The University of North Carolina for the 2017-2018 fiscal year set
9 forth in this act shall be decreased by the sum of nineteen million eight hundred sixty-five
10 thousand five hundred forty-four dollars (\$19,865,544) for the 2017-2018 fiscal year.";
