## **"PART IX. SAFE STORAGE OF FIREARMS.**

**SECTION 9.(a)** G.S. 14-315.1 is repealed.

SECTION 9.(b) Article 39 of Chapter 14 of the General Statutes is amended by 6 7 adding a new section to read:

## 8 "§ 14-315.3. Safe storage of firearms. 9

The following definitions apply in this section: (a)

- Minor. A person under 18 years of age who is not emancipated. (1)
- Unauthorized person. A person who is not authorized to purchase a firearm (2) under State or federal law.

13 Any person who resides on the same premises as a minor or as an unauthorized (b) 14 person, and who owns or possesses a firearm, and who stores or leaves the firearm out of the 15 person's immediate possession or control without having first securely locked the firearm in an appropriate safe storage depository or rendered it incapable of being fired by the use of a safety 16

locking device appropriate to the firearm is guilty of a Class 1 misdemeanor. 17

Nothing in this section shall prohibit a person from carrying a firearm on his or her 18 (c) body or placed in such close proximity that it can be used as easily and quickly as if carried on 19 20 the body."

**SECTION 9.(c)** G.S. 14-315.2(a) reads as rewritten:

22 "§ 14-315.2. Warning upon sale or transfer of firearm to protect minor.

23 Upon the retail commercial sale or transfer of any firearm, the seller or transferor (a) 24 shall deliver a written copy of G.S. 14-315.1-G.S. 14-315.3 to the purchaser or transferee."

SECTION 9.(d) This section is effective on December 1, 2017, and applies to 25 offenses committed on or after that date."; 26 27
