7 "SECTION 2. Notwithstanding Section 5(f) and Section 5(h) of the Merger Plan,
8 beginning in 2018, vacancies on the Union County Board of Education shall be filled as
9 follows:

- 10 (1) Vacancies for positions elected on a nonpartisan basis in 2014 or 2016 shall
- 11 be filled in accordance with G.S. 115C-37(f).
- 12 (2) Vacancies for positions elected on a partisan basis in 2018 and thereafter
- 13 shall be filled by appointment for the remainder of the unexpired term by the
- 14 remaining Board members. If the vacating member was elected as a nominee
- 15 of a political party, the Board shall consult the county executive committee
- 16 of the appropriate political party before filling the vacancy, and shall appoint
- 17 the person recommended by the county executive committee of the political
- 18 party of which the vacating member is registered, if that county executive
- 19 committee makes a recommendation within 30 days of the occurrence of the
- 20 vacancy. If only the qualified voters of an area less than the entire county
- 21 were eligible to vote in the general election for the vacating member, the
- 22 Board must accept the recommendation of the county executive committee
- 23 only if the county executive committee restricted voting to committee
- 24 members who represent precincts all or part of which were within the
- 25 electoral district of the vacating member. To be eligible to fill a vacancy, a
- 26 person shall be all of the following:
- 27 a. Registered with the same political party as the vacating member, if
- 28 that vacating member was elected as the nominee of a political party.
- 29 b. A resident of the same district as the vacating member, if the
- 30 vacating member was elected to represent an electoral district of less
- 31 than the entire county. ";

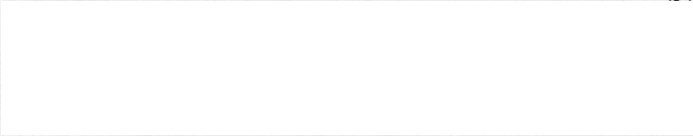
