1 A BILL TO BE ENTITLED
2 AN ACT TO AUTHORIZE THE DIVISION OF MOTOR VEHICLES TO PRODUCE A
3 COLORECTAL CANCER AWARENESS SPECIAL REGISTRATION PLATE, A BIG
4 ROCK BLUE MARLIN TOURNAMENT SPECIAL REGISTRATION PLATE, AND A
5 KICK CANCER FOR KIDS SPECIAL REGISTRATION PLATE.

6 The General Assembly of North Carolina enacts:

7 **SECTION 1.** G.S. 20-63(b1) reads as rewritten:

8 "(b1) The following special registration plates do not have to be a "First in Flight" plate or
9 "First in Freedom" plate as provided in subsection (b) of this section. The design of the plates
10 that are not "First in Flight" plates or "First in Freedom" plates must be developed in
11 accordance with G.S. 20-79.4(a3). For special plates authorized in G.S. 20-79.7 on or after July
12 1, 2013, the Division may not issue the plate on a background under this subsection unless it
13 receives ~~at least 200 applications for the plate in addition to the applications required under~~
14 ~~G.S. 20-79.4 or G.S. 20-81.12~~ the required number of applications set forth in
15 G.S. 20-79.3A(a).

18 (55) Big Rock Blue Marlin Tournament.

19 (56) Order of the Long Leaf Pine."

20 **SECTION 2.** G.S. 20-79.4(b) reads as rewritten:

21 "(b) Types. – The Division shall issue the following types of special registration plates:

23 () Big Rock Blue Marlin Tournament. – Issuable to the registered owner of a
24 motor vehicle in accordance with G.S. 20-81.12. The plate shall bear the
25 words "Big Rock Blue Marlin Tournament" and include a representation of a
26 blue marlin.

28 () Colorectal Cancer Awareness. – Issuable to the registered owner of a motor
29 vehicle in accordance with G.S. 20-81.12. The plate shall bear (i) the phrase
30 "It Takes a Warrior to Battle Cancer!" across the top of the plate, (ii) a
31 symbol on the left side of the plate of a blue ribbon with two wings that are
32 colored blue, grey, and black, (iii) the phrase "Blue Ribbon Warrior" above
33 the symbol, (iv) the phrase "Colorectal Cancer Awareness" below the
34 symbol, and (v) the letters "CC" on the right side of the plate. The plate
35 authorized under this subdivision is not subject to G.S. 20-79.3A(c) or the
36 deadline set forth in G.S. 20-79.3A(b).

 2 () Kick Cancer for Kids. – Issuable to the registered owner of a motor vehicle
 3 in accordance with G.S. 20-81.12. The plate shall bear the words "Kick
 4 Cancer for Kids" and a representation of a gold ribbon with children's
 5 handprints surrounding the ribbon.

7 **SECTION 3.** G.S. 20-79.7 reads as rewritten:

8 **"§ 20-79.7. Fees for special registration plates and distribution of the fees.**

9 ...
 10 (a1) Fees. – All other special registration plates are subject to the regular motor vehicle
 11 registration fee in G.S. 20-87 or G.S. 20-88 plus an additional fee in the following amount:

 25 (b) Distribution of Fees. – The Special Registration Plate Account and the Collegiate
 26 and Cultural Attraction Plate Account are established within the Highway Fund. The Division
 27 must credit the additional fee imposed for the special registration plates listed in subsection (a)
 28 of this section among the Special Registration Plate Account (SRPA), the Collegiate and
 29 Cultural Attraction Plate Account (CCAPA), the Clean Water Management Trust Fund
 30 (CWMTF), which is established under G.S. 113A-253, and the Parks and Recreation Trust
 31 Fund, which is established under G.S. 113-44.15, as follows:

 44 **SECTION 4.** G.S. 20-81.12 reads as rewritten:

45 **"§ 20-81.12. Collegiate insignia plates and certain other special plates.**

 47 (b155) Colorectal Cancer Awareness. – The Division must receive 300 or more
 48 applications for a Colorectal Cancer Awareness plate before the plate may be developed. The
 49 Division shall transfer quarterly the money in the Collegiate and Cultural Attraction Plate
 50 Account derived from the sale of Colorectal Cancer Awareness plates to the Colon Cancer

1 Coalition to be used to promote prevention and early detection of colorectal cancer and to
2 provide support to persons affected.

3 (b156) Kick Cancer for Kids. – The Division shall transfer quarterly the money in the
4 Collegiate and Cultural Attraction Plate Account derived from the sale of Kick Cancer for Kids
5 plates as follows:

6 (1) Fifty percent (50%) to The Children's Oncology Group Foundation to be
7 used to provide support for the mission and goals of the Foundation.

8 (2) Fifty percent (50%) to Riley's Army, Inc., to be used to provide support to
9 children with cancer and their families.

10 (b157) Big Rock Blue Marlin Tournament. – The Division shall transfer quarterly the
11 money in the Collegiate and Cultural Attraction Plate Account derived from the sale of Big
12 Rock Blue Marlin Tournament plates to the Big Rock Blue Marlin Tournament to be used to
13 fund charities in North Carolina."

14 **SECTION 5.** The Revisor of Statutes is authorized to alphabetize, number, and
15 renumber the special registration plates listed in G.S. 20-79.4(b) to ensure that all the special
16 registration plates are listed in alphabetical order and numbered accordingly.

17 **SECTION 6.** This act is effective when it becomes law.
