10 "§ 143-548. Vocational Rehabilitation Council.

12 (d1) Terms of Appointment. –

13 (1) Length of Term. – Each member of the Council shall serve for a term of not
14 more than three years, except that:

15 a. A member appointed to fill a vacancy occurring prior to the
16 expiration of the term for which a predecessor was appointed shall be
17 appointed for the remainder of that term;

18 b. The terms of service of the members initially appointed are as
19 specified by the appointing authority for a fewer number of years as
20 will provide for the expiration of terms on a staggered basis and shall
21 include the members of the existing Council to the extent possible
22 with appropriate adjustments to their terms;

23 c. The appointing authority shall have the power to remove any
24 member of the Council from office in accordance with the provisions
25 of G.S. 143B-16; and

26 d. A member may continue to serve until a successor for the position is
27 appointed;

28 (2) Number of Terms. – No member of the Council other than the representative
29 of the Client Assistance ~~Program~~ Program, the representative of a parent
30 training and information center, and the representative of the directors of
31 projects carried out under section 121 of the Rehabilitation Act of 1973, 29
32 U.S.C. § 741, as amended, may serve more than two consecutive full terms.

7 members, chosen as follows:

9 All regular appointments or elections except those by the General Assembly shall be for terms

10 of six years, except that each member shall serve until the member's successor is chosen and

11 qualifies. No person may be appointed or elected to more than two consecutive terms of six

12 years. All ~~regular~~ appointments by the General Assembly shall be for ~~the then current~~

13 legislative term, and ~~no appointee of the General Assembly may be appointed to more than two~~

14 consecutive terms of ~~two years.~~ four years, with no person being appointed to more than three

15 consecutive terms.
