Representative Lewis

1 moves to amend the bill on page 1, lines 31-32, by inserting between those lines the following
2 new language to read:

3 "SECTION 1.1.(a) Section 5.3(e) of S.L. 2017-57 reads as rewritten:

4 "SECTION 5.3.(e) Grant funds awarded under this section shall be subject to a matching
5 requirement from the recipient county as follows:

6 (1) For a county designated as a development tier one area, the grant shall not
7 exceed three dollars (\$3.00) in grant funds for every one dollar (\$1.00)
8 provided by the county. Grant funds awarded to a tier one county shall not
9 exceed fifteen million dollars (\$15,000,000).

10 (2) For a county designated as a development tier two area, the grant shall not
11 exceed one dollar (\$1.00) for every one dollar (\$1.00) in grant funds
12 provided by the county. Grant funds awarded to a tier two county shall not
13 exceed ten million dollars (\$10,000,000).

14 Grant funds shall be used for new capital projects only. Grant funds shall not be
15 used for real property acquisition or for operational lease ~~agreements~~ agreements, except that
16 grant funds may be used for projects when a pre-development agreement for an operational
17 lease was entered into on or before June 30, 2017. Notwithstanding subdivision (2) of this
18 subsection, grant funds shall only be awarded to development tier one counties until the
19 2020-2021 fiscal year. Grant funds shall not be awarded to any county that has received over
20 eight million seven hundred fifty thousand dollars (\$8,750,000) in funds from the Public
21 School Building Capital Fund from the 2012-2013 fiscal year to the 2016-2017 fiscal year."

22 "SECTION 1.1.(b) This section becomes effective July 1, 2017."; and

24 on page 1, line 32, by rewriting that line to read:

25 "SECTION 2. Except as otherwise provided, this act is effective when it becomes law and
26 applies to bond".
