3 RECOMMENDATION OF THE PRESIDENT PRO TEMPORE OF THE SENATE AND
4 THE SPEAKER OF THE HOUSE OF REPRESENTATIVES AND TO MAKE FURTHER
5 MODIFICATIONS TO APPOINTMENTS MADE IN THE 2017 APPOINTMENTS
6 BILLS.

7 The General Assembly of North Carolina enacts:

9 **PART I. PRESIDENT PRO TEMPORE'S RECOMMENDATIONS**

10 **SECTION 1.1.** Senator Tom McInnis of Richmond County and Senator Jim Davis
11 of Macon County are appointed to Virginia-North Carolina High-Speed Rail Compact
12 Commission to serve at the pleasure of the appointing authority.

13 **SECTION 1.2.** David W. Jessen of Wake County is appointed to the Ferry
14 Transportation Authority Board of Trustees for a term expiring on June 30, 2018.

15 **SECTION 1.3.** William M. Nichols of Wake County is appointed to the North
16 Carolina Sheriffs' Education and Training Standards Commission for a term expiring on June
17 30, 2020.

33 is extended from June 30, 2018 to December 31, 2018.

36 SECTION 4. Unless otherwise provided, this act is effective when it becomes law.
