25 section, in 2018 and every eight years thereafter, elections shall be conducted for two seats in
26 District 26A, one seat in District 26B, and one seat in District 26C; in 2020 and every eight years
27 thereafter, elections shall be conducted for one seat in District 26A and one seat in District 26C;
28 and in 2022 and every eight years thereafter, elections shall be conducted for two seats in District
29 26B and one seat in District 26C.";
