3 THE DIVISION TO PRODUCE AN "ORDER OF THE EASTERN STAR PRINCE HALL  
4 AFFILIATED" SPECIAL REGISTRATION PLATE, AND TO"; and

6 on page 3, lines 3-4, by adding the following between the lines:

8 **"AUTHORIZE THE DIVISION TO PRODUCE AN "ORDER OF THE EASTERN STAR

10 **SECTION 3.5.(a)** G.S. 20-79.4(b) reads as rewritten:

11 (b) Types. – The Division shall issue the following types of special registration plates:

13 () Order of the Eastern Star Prince Hall Affiliated. – Issuable to an active  
14 member of the Order of the Eastern Star Prince Hall Affiliated in accordance  
15 with G.S. 20-81.12. The plate shall bear the Order of the Eastern Star Prince  
16 Hall Affiliated logo.

18 **SECTION 3.5(b)** G.S. 20-79.7 reads as rewritten:

19 **"§ 20-79.7. Fees for special registration plates and distribution of the fees.**

21 (a1) Fees. – All other special registration plates are subject to the regular motor vehicle  
22 registration fee in G.S. 20-87 or G.S. 20-88 plus an additional fee in the following amount:

22 registration plates are listed in alphabetical order and numbered accordingly.
