4 The General Assembly of North Carolina enacts:

5 SECTION 1. G.S. 163A-1114 reads as rewritten:

6 "§ 163A-1114. Arrangement of official ballots.

8 (c) Order of Candidates on ~~Primary and Nonpartisan~~ Official Ballots. – The order in
9 which candidates shall appear on a county's official ballots in any (i) ~~primary ballot item, whether~~
10 ~~the primary is partisan or nonpartisan, and (ii) in any nonpartisan general election ballot item~~
11 ~~under Article 25 of this Chapter shall be determined by the county board of elections using a~~
12 ~~process designed by the State Board for random selection. The same random selection process~~
13 ~~shall be used for all primaries and elections in a calendar year.~~ election ballot item shall be either
14 alphabetical order or reverse alphabetical order by the last name of the candidate, which order
15 shall be determined each election by drawing at the State Board of Elections and Ethics
16 Enforcement after the closing of the filing period for all offices on the ballot.

17 (d) ~~Order of Party Candidates on General Election Official Ballot. — Candidates in any~~

30 (1) ~~Candidates registered with political parties that reflect at least five percent~~
31 ~~(5%) of statewide voter registration, according to the most recent statistical~~
32 ~~report published by the State Board, in alphabetical order by party beginning~~
33 ~~with the party whose nominee for Governor received the most votes in the~~
34 ~~most recent gubernatorial election and in alphabetical order within the party.~~

3 **SECTION 2.** This act is effective when it becomes law and applies to elections held
4 on or after that date. Notwithstanding G.S. 163A-1114, as enacted by this act, elections held in
5 2018 shall be conducted using the random selection process previously determined by the State
6 Board of Elections and Ethics Enforcement for all primaries and elections in 2018. No further
7 drawing shall be conducted for any ballot item for the 2018 election.
