- 1 moves to amend the bill on page 8, lines 17-28, by rewriting the lines to read:
- 2       "(c) The Department shall release data in the controlled substances reporting system to the
- 3 following persons only:
- 4           ...
- 5           (5) To a sheriff or designated deputy sheriff or a police chief or a designated
- 6 police investigator who is assigned to investigate the diversion and illegal use
- 7 of prescription medication or pharmaceutical products identified in Article 5
- 8 of this Chapter of the General Statutes as Schedule II through V controlled
- 9 substances and who is engaged in a bona fide specific investigation related to
- 10 the enforcement of laws governing licit drugs pursuant to a lawful court order
- 11 specifically issued for that purpose.
- 12           (5a) Local law enforcement officers pursuant to subsection (i) of this section.
- 13           ..."; and
- 14 on page 9, line 24, by rewriting the line to read:
- 15           "a. Bona fide active investigation. – An investigation of one or more specific
- 16 persons conducted with a reasonable, good-faith belief based on specific facts and circumstances
- 17 equivalent to those normally necessary for the issuance of a court order, as described in
- 18 G.S. 90-113.74(c)(5).
- 19           a1. Certified diversion investigator. – An officer affiliated with a qualified"; and
- 20 on page 9, lines 49-50, and page 10, lines 1-2, by deleting the lines; and
- 21 on page 8, line 39, by rewriting the line to read:
- 22           "controlled substance."; and
- 23 on page 10, line 15, by rewriting the line to read:
- 24           "involving a controlled substance by providing, at a minimum, all of the".


