and on page 3, lines 36-40, by rewriting those lines to read:

"filled as provided in G.S. 120-122. If that vacancy occurs in a term expiring in an odd year, and the General Assembly is not in a regular or extra session at the time of the vacancy, the Governor shall consult with the Speaker of the House before making the appointment as required by G.S. 120-122. If that vacancy occurs in a term expiring in an even year, and the General Assembly is not in a regular or extra session at the time of the vacancy, the Governor shall consult with the President Pro Tempore before making the appointment as required by G.S. 120-122. Notwithstanding G.S. 120-122, after receiving the written recommendation for the appointment to fill that vacancy, the Governor must within 30 days appoint the person recommended, and shall not reject the recommendation. Upon expiration of that term, the member shall be appointed in accordance with G.S. 115D-12.

**SECTION 2.(c)** This section applies only to Cleveland Community College.";
