17 school unit, as defined in subdivision (2) of this subsection.

18 (2) K-12 school unit. – Any of the following:

19 a. A local school administrative unit.

20 b. A regional school authorized under Part 10 of Article 16 of Chapter  
21 115C of the General Statutes.

22 c. A charter school authorized under Article 14C of Chapter 115C of the  
23 General Statutes.

24 d. A school providing secondary instruction operated by the State Board  
25 of Education, including schools operated under Article 9C of Chapter  
26 115C of the General Statutes.

27 e. A nonpublic school authorized under Part 1 of Part 2 of Article 39 of  
28 Chapter 115C of the General Statutes.

29 (3) Superintendent. – The superintendent of a local school administrative unit or,  
30 for a K-12 school unit with no superintendent, the staff member with the  
31 highest decision making authority."
