1 moves to amend the bill on page 8, lines 24-28, by rewriting those lines to read:

2            "(4)    When the threat assessment team makes a recommendation that the student be  
3                    referred for mental health services, the superintendent or designee shall notify  
4                    the student's parent or legal guardian of all of the following information:

5                    a.        That the threat assessment team has recommended that the student be  
6                    referred for mental health services.

7                    b.        That if the student is covered by private insurance or a Medicaid  
8                    prepaid health plan, then the parent or guardian is encouraged to  
9                    contact the student's primary care provider or insurance company.

10                   c.        That if the student is uninsured or is covered by Medicaid and not  
11                   enrolled in a prepaid health plan, then the parent or guardian is  
12                   encouraged to contact the local management entity/managed care  
13                   organization that serves the catchment area where the student resides.

14                   d.        That with the parent or legal guardian's consent, if the student is  
15                   uninsured or is covered by Medicaid and not enrolled in a prepaid  
16                   health plan, then the superintendent or designee shall make a referral  
17                   that includes the parent or guardian's contact information to the local  
18                   management entity/managed care organization that serves the  
19                   catchment area where the student resides.";
