1 moves to amend the bill on page 1, line 4, by deleting "ELECTIONS." and substituting the
 2 following:
 3 "ELECTIONS AND TO EXTEND THE DEADLINE BY WHICH THE STATE BOARD OF
 4 ELECTIONS IS REQUIRED TO APPROVE THE USE OF CERTAIN FORMS OF
 5 IDENTIFICATION FOR VOTING.";

 7 and on page 2, lines 4-5, by inserting between the lines the following:
 8 "SECTION 2.1. Section 1.2(f) of S.L. 2018-144 reads as rewritten:
 9 "SECTION 1.2.(f) Notwithstanding G.S. 163A-1145.1, 163A-1145.2, and
 10 163A-1145.3, the State Board shall approve (i) tribal enrollment cards issued by a tribe
 11 recognized by this State under Chapter 71A of the General Statutes; (ii) student identification
 12 cards issued by a constituent institution of The University of North Carolina, a community
 13 college, as defined in G.S. 115D-2(2), or eligible private postsecondary institution as defined in
 14 G.S. 116-280(3); and (iii) employee identification cards issued by a state or local government
 15 entity, including a charter school, for use as voting identification under G.S. 163A-1145.1 no
 16 later than ~~March 15, 2019, September 15, 2019,~~ for use in primaries and elections held in 2019
 17 and 2020, and again no later than May 15, 2021, for elections held on or after that date. The State
 18 Board shall adopt temporary rules on reasonable security measures for use of student or employee
 19 identification cards for voting identification in G.S. 163A-1145.2 and G.S. 163A-1145.3 no later
 20 than ~~February 1, 2019, August 1, 2019.~~ The State Board shall adopt permanent rules on
 21 reasonable security measures for use of student or employee identification cards for voting
 22 identification in G.S. 163A-1145.2 and G.S. 163A-1145.3 no later than May 15, 2021. The State
 23 Board shall produce the initial list of participating institutions and employing entities no later
 24 than ~~April 1, 2019, October 1, 2019.~~"
