G.S. 20-63(b1) is amended by adding a new subdivision to read: 6 "(58) POW/MIA Bring Them Home." 7 SECTION 2. G.S. 20-79.4(b) reads as rewritten: 8 Types. – The Division shall issue the following types of special registration plates: "(b) 9 . . . 10 POW/MIA Bring Them Home. - The plate shall have the phrase "POW/MIA 0 Bring Them Home" with artwork submitted by Rolling Thunder, Inc., Chapter 11 #1 North Carolina and reviewed by the Division to ensure compliance with 12 G.S. 20-79.4(a3). A person may obtain from the Division a special registration 13 plate under this subdivision for the registered owner of a motor vehicle or a 14 motorcycle. The division may not issue a plate authorized under this 15 subdivision until it receives at least 350 applications for the plate. 16 Applications for motor vehicle special registration plates and motorcycle 17 special registration plates received by the Division each count towards the 18 minimum number of applications necessary to issue a plate under this 19 20 subdivision." SECTION 3. G.S. 20-79.7 reads as rewritten: 21 22 "§ 20-79.7. Fees for special registration plates and distribution of the fees. 23 24 (a1) Fees. – All other special registration plates are subject to the regular motor vehicle 25 registration fee in G.S. 20-87 or G.S. 20-88 plus an additional fee in the following amount: 26 Special Plate Additional Fee Amount 27 . . . 28 **Piedmont Airlines** \$20.00 29 POW/MIA Bring Them Home \$20.00 Prince Hall Mason 30 \$20.00 31 32 Distribution of Fees. - The Special Registration Plate Account and the Collegiate and (b) 33 Cultural Attraction Plate Account are established within the Highway Fund.
