2 AN ACT TO INCREASE THE MAXIMUM FEE FOR APPLICATION FOR  
3 CERTIFICATION OF AND FOR RENEWAL OF A COMPANY POLICE AGENCY AND  
4 A COMPANY POLICE OFFICER AND FOR APPLICATION FOR CERTIFICATION OF  
5 AND FOR RENEWAL OF A CAMPUS POLICE AGENCY AND A CAMPUS POLICE  
6 OFFICER.

7 The General Assembly of North Carolina enacts:

8 **SECTION 1.** G.S. 74E-12 reads as rewritten:

9 "**§ 74E-12. Fees.**

10 The Attorney General may charge fees for the items listed in the following table, not to  
11 exceed the amounts listed in the table:
