SENATE BILL DRS45028-ML-49

Short Title: Revise Marijuana Laws.

(Public)

Sponsors: Senators Lowe, Foushee, and Fitch (Primary Sponsors).

Referred to:

1 A BILL TO BE ENTITLED  
2 AN ACT TO INCREASE THE AMOUNT OF MARIJUANA THAT MAY BE LEGALLY  
3 POSSESSED FOR PERSONAL USE AND TO ALLOW FOR THE EXPUNCTION OF  
4 RECORDS RELATED TO CERTAIN CONVICTIONS FOR POSSESSION OF  
5 MARIJUANA.

6 The General Assembly of North Carolina enacts:

7 **SECTION 1.** G.S. 90-95 reads as rewritten:

8 "**§ 90-95. Violations; penalties.**

9 (a) Except as authorized by this Article, it is unlawful for any person:

10 ...

11 (3) To possess a controlled substance. For purposes of this subdivision, the term  
12 "controlled substance" does not include marijuana in quantities of four ounces  
13 (avoirdupois) or less.

14 ...

15 (d) Except as provided in subsections (h) and (i) of this section, any person who violates  
16 G.S. 90-95(a)(3) with respect to:

17 ...

18 (4) A controlled substance classified in Schedule VI shall be guilty of a Class 3  
19 misdemeanor, but any sentence of imprisonment imposed must be suspended  
20 and the judge may not require at the time of sentencing that the defendant  
21 serve a period of imprisonment as a special condition of probation. If the  
22 quantity of the controlled substance exceeds ~~one-half of an ounce~~ three ounces  
23 (avoirdupois) of marijuana or one-twentieth of an ounce (avoirdupois) of the  
24 extracted resin of marijuana, commonly known as hashish, the violation shall  
25 be punishable as a Class 1 misdemeanor. If the quantity of the controlled  
26 substance exceeds ~~one and one-half~~ 16 ounces (avoirdupois) of marijuana, or  
27 three-twentieths of an ounce (avoirdupois) of the extracted resin of marijuana,  
28 commonly known as hashish, or if the controlled substance consists of any  
29 quantity of synthetic tetrahydrocannabinols or tetrahydrocannabinols isolated  
30 from the resin of marijuana, the violation shall be punishable as a Class I  
31 felony.

33 **SECTION 2.** Article 5 of Chapter 15A of the General Statutes is amended by adding  
34 a new section to read:

35 "**§ 15A-145.8. Expunction of certain possession of marijuana offenses.**



1        (a) A person who was convicted of a violation of G.S. 90-95(a)(3) for possession of  
2 marijuana, where the quantity of marijuana possessed was three ounces (avoirdupois) or less,  
3 may file a petition in the court of the county where the person was convicted for expunction of  
4 the offense from the person's criminal record and any other official record containing an entry  
5 relating to the person's apprehension, charge, trial, or conviction. The court, after notice to the  
6 district attorney, shall hold a hearing on the petition and, upon finding that the violation of  
7 G.S. 90-95(a)(3) involved possession of marijuana in an amount of three ounces (avoirdupois)  
8 or less, the court shall order the expunction.

9        (b) Any petition for expunction under this section shall be on a form approved by the  
10 Administrative Office of the Courts and be filed with the clerk of superior court. Upon order of  
11 expungement, the clerk shall forward the petition to the Administrative Office of the Courts.

12        (c) No person as to whom such an order has been entered under this section shall be held  
13 thereafter under any provision of any law to be guilty of perjury, or to be guilty of otherwise  
14 giving a false statement or response to any inquiry made for any purpose, by reason of the  
15 person's failure to recite or acknowledge any expunged entries concerning apprehension, charge,  
16 or trial.

17        (d) The court shall also order that the conviction ordered expunged under this section be  
18 expunged from the records of the court and direct all law enforcement agencies bearing record  
19 of the same to expunge their records of the conviction. The clerk shall notify State and local  
20 agencies of the court's order as provided in G.S. 15A-150.

21        (e) Any other applicable State or local government agency shall expunge from its records  
22 entries made as a result of the conviction ordered expunged under this section. The agency shall  
23 also reverse any administrative actions taken against a person whose record is expunged under  
24 this section as a result of the charges or convictions expunged. This subsection shall not apply to  
25 the Department of Justice for DNA records and samples stored in the State DNA Database and  
26 the State DNA Databank.

27        (f) A person who files a petition for expunction under this section must pay the clerk of  
28 superior court a fee of one hundred dollars (\$100.00) at the time the petition is filed. Fees  
29 collected under this subsection shall be deposited in the General Fund. This subsection does not  
30 apply to petitions filed by an indigent."

31        **SECTION 3.** Section 1 of this act becomes effective July 1, 2019, and applies to  
32 offenses committed on or after that date. The remainder of this act becomes effective July 1,  
33 2019.
