1 A BILL TO BE ENTITLED
2 AN ACT REQUIRING NURSING HOMES, COMBINATION HOMES, AND ADULT CARE
3 HOMES TO HAVE EMERGENCY ELECTRICAL SERVICE AVAILABLE FOR USE
4 DURING POWER OUTAGES.

5 The General Assembly of North Carolina enacts:

6 SECTION 1. Article 1 of Chapter 131D of the General Statutes is amended by
7 adding a new section to read:

8 "**§ 131D-4.3A. Emergency electrical service required.**

9 Notwithstanding any other provision of law to the contrary, all adult care homes, as defined
10 in G.S. 131D-2.1, licensed pursuant to this Article, and operating in this State shall provide
11 emergency electrical service for use in the event of failure of the normal electrical service. Each
12 facility subject to this section shall provide emergency electrical service sufficient to provide
13 heat, air conditioning, lighting, and other essential electrical services required by rules of the
14 Medical Care Commission."

15 SECTION 2. Part 1 of Article 6 of Chapter 131E of the General Statutes is amended
16 by adding the following new section to read:

17 "**§ 131E-114.3A. Emergency electrical service required.**

18 Notwithstanding any other provision of law to the contrary, all nursing homes, combination
19 homes, and adult care homes, as those terms are defined in G.S. 131E-101, licensed and operating
20 in this State shall provide emergency electrical service for use in the event of failure of the normal
21 electrical service. Each facility subject to this section shall provide emergency electrical service
22 sufficient to provide heat, air conditioning, lighting, and other essential electrical services
23 required by rules of the Medical Care Commission."

24 SECTION 3. G.S. 143B-165 is amended by adding a new subdivision to read:

25 "(14) The Commission shall adopt rules specifying the essential electrical services
26 nursing homes, combination homes, and adult care homes are required to
27 provide through the use of emergency electrical services pursuant to
28 G.S. 131D-4.3A and G.S. 131E-114.3A."

29 SECTION 4. Section 3 of this act and this section become effective when this act
30 becomes law. The remainder of this act becomes effective on the date the rules adopted by the
31 Medical Care Commission, pursuant to G.S. 143B-165(14), as amended by this act, become
32 effective. The Medical Care Commission shall notify the Revisor of Statutes of the date the rules
33 become effective.
