1 A BILL TO BE ENTITLED  
2 AN ACT TO AUTHORIZE NONPROFIT ORGANIZATIONS TO OPERATE "GAME  
3 NIGHTS," TO PROVIDE FOR THE REGULATION OF NONPROFIT ORGANIZATIONS  
4 HOLDING "GAME NIGHTS," AND TO ALLOW THE CONSUMPTION OF  
5 ALCOHOLIC BEVERAGES AT "GAME NIGHTS."

6 The General Assembly of North Carolina enacts:

7 **SECTION 1.** G.S. 14-292 reads as rewritten:

8 **"§ 14-292. Gambling.**

9 Except as provided in Chapter 18C of the General Statutes or in Part 2 or Part 4 of this Article,  
10 any person or organization that operates any game of chance or any person who plays at or bets  
11 on any game of chance at which any money, property or other thing of value is bet, whether the  
12 same be in stake or not, shall be guilty of a Class 2 misdemeanor. This section shall not apply to  
13 a person who plays at or bets on any lottery game being lawfully conducted in any state."

14 **SECTION 2.** Article 37 of Chapter 14 of the General Statutes is amended by adding  
15 a new Part to read:

16 "Part 4. Game Nights.

17 **"§ 14-309.25. Definitions.**

18 The following definitions apply in this Part:

- 19 (1) Exempt organization. – An organization that has been in continuous existence  
20 for at least five years and that is exempt from taxation under section 501(c)(3),  
21 501(c)(4), 501(c)(5), or 501(c)(6) of the United States Internal Revenue Code.  
22 (2) Game night. – A specific event at which games of chance are played and prizes  
23 are awarded by raffle and that is sponsored by or on behalf of an exempt  
24 organization for the primary purpose of raising funds for the exempt  
25 organization or is sponsored by an employer or trade association pursuant to  
26 G.S. 14-309.34.  
27 (3) Local law enforcement agency. – Any county or municipal law enforcement  
28 agency that has territorial and subject matter jurisdiction over the location at  
29 which the game night is being held.  
30 (4) Qualified facility. – As defined in G.S. 18B-1000.

31 **"§ 14-309.26. Game nights.**

1       (a)     It is lawful for an exempt organization to conduct a game night at a qualified facility  
2 in accordance with the provisions of this Part. Each regional or county chapter of an exempt  
3 organization shall be eligible to conduct game nights in accordance with this Part independently  
4 of its parent organization, provided that the regional or county chapter has been in continuous  
5 existence for at least five years. It is lawful for persons to participate in a game night conducted  
6 pursuant to this Part. It shall not constitute a violation of any State law to advertise a game night  
7 conducted in accordance with this Part.

8       (b)     If any exempt organization conducts a game night in violation of any provision of this  
9 Part, the person indicated in G.S. 14-309.27(b)(2) is guilty of a Class 2 misdemeanor. In addition  
10 to any fine that may be imposed, an exempt organization convicted of a violation under this Part  
11 shall not conduct a game night for a period of one year from the date of the conviction.

12 **"§ 14-309.27. Permit procedure.**

13       (a)     An exempt organization shall not operate a game night without first obtaining a permit  
14 as provided by this Part. The application for a game night permit shall be on a form prescribed  
15 by the Alcohol Law Enforcement Branch of the Department of Public Safety and shall be  
16 submitted to the Alcohol Law Enforcement Headquarters at least 30 days in advance of the date  
17 for the game night event.

18       (b)     Each application for a permit under this Part shall contain the following information:

- 19           (1)     The name and address of the exempt organization that is applying for the  
20 permit.
- 21           (2)     The name, address, and signature of the person applying on behalf of the  
22 exempt organization and who will be responsible for the event.
- 23           (3)     Verification of the tax-exempt status of the exempt organization, except, if the  
24 applicant is a local chapter, division, lodge, or branch of the exempt  
25 organization, then verification of the tax-exempt status of the parent  
26 organization.
- 27           (4)     Verification of the exempt organization's status as a licensed or exempt  
28 charitable or sponsor organization pursuant to Chapter 131F of the General  
29 Statutes.
- 30           (5)     The time, duration, date, and place of the event.
- 31           (6)     The games proposed to be operated.
- 32           (7)     The name and address of the person, firm, or corporation who will operate the  
33 games and the relationship, if any, of such person, firm, or corporation to the  
34 exempt organization or qualified facility.
- 35           (8)     The area of the premises in which the event will be held.

36       (c)     A separate application shall be required for each game night event. A fee of one  
37 hundred dollars (\$100.00) shall be charged for each permit. The permit fees assessed under this  
38 Part are payable to the Alcohol Law Enforcement Branch of the Department of Public Safety and  
39 shall be collected and used by the Alcohol Law Enforcement Branch to defray the costs of issuing  
40 game night permits. The permit shall be displayed at the event. A qualified facility shall not be  
41 subject to civil or criminal liability for violating this Part if the exempt organization provides the  
42 facility with a permit for the game night event.

43 **"§ 14-309.28. Limits on game night events.**

44       The following limitations apply to game night events:

- 45           (1)     The number of game night events conducted or sponsored by an exempt  
46 organization shall be limited to four events per year.
- 47           (2)     The event shall not exceed a period of five hours each per event. No more than  
48 one game night event shall be held in any quarter of a calendar year that begins  
49 January 1.
- 50           (3)     No more than two game night events shall be operated or conducted in any  
51 one building, hall, or structure during any one calendar week, and if two events

1 are held, they must be held by different exempt organizations on different  
2 nights of the week.

3 (4) There shall be no operation of a game night event between the hours of 2:00  
4 A.M. and 12:00 noon Monday through Saturday or between the hours of 2:00  
5 A.M. and 2:00 P.M. Sunday.

6 (5) A qualified facility, as defined in G.S. 18B-1000(5a), shall not host more than  
7 two game nights in any calendar month.

8 **"§ 14-309.29. Game night; prizes and costs.**

9 (a) Prizes. – No games at a game night event may be played for cash or a cash prize.  
10 Prizes shall be awarded only through a raffle. Participants may exchange chips, markers, or  
11 tokens from the game night event for raffle tickets. For purposes of this subsection, the term  
12 "cash prize" includes gift cards that are issued by a financial institution or its operating subsidiary  
13 and that are usable at multiple unaffiliated sellers of goods or services.

14 (b) Costs. – The cost of the prizes and expenses to operate the game night event,  
15 excluding the cost of food, beverages, and entertainment, shall not exceed the proceeds derived  
16 from the event. If the exempt organization hires a game night vendor for the event, payment shall  
17 be by fixed fee.

18 **"§ 14-309.30. Operation of game night events.**

19 The following games are the only games that may be played at a game night event:

- 20 (1) Roulette.
- 21 (2) Blackjack.
- 22 (3) Poker.
- 23 (4) Craps.
- 24 (5) Simulated horse race.
- 25 (6) Merchandise wheel of fortune.

26 **"§ 14-309.31. Use of proceeds.**

27 The exempt organization may use its own funds or funds received in connection with the  
28 game night for prizes, advertising, utilities, space rental, and the purchase or rental of supplies  
29 and equipment, including game night tables and related equipment, used in conducting the games.  
30 Net proceeds from the game night shall inure to the benefit of the exempt organization and shall  
31 be used to further the organization's tax-exempt purposes.

32 **"§ 14-309.32. Violation is gambling.**

33 A game night conducted other than in accordance with the provisions of this Part is  
34 "gambling" within the meaning of G.S. 14-292 and G.S. 19-1, et seq., and proceedings against  
35 such game night may be instituted as provided for in Chapter 19 of the General Statutes.

36 **"§ 14-309.33. Applicability.**

37 This Part is only applicable in areas of the State located east of I-26 as that interstate highway  
38 was located on November 28, 2011.

39 **"§ 14-309.34. Applicability to employer paid events.**

40 (a) It shall be lawful (i) for an employer, with 25 or more employees, to hold a game  
41 night event for employees and guests or a trade association, with 25 or more members, to hold a  
42 game night event for its members and guests, and (ii) for persons to participate in a game night  
43 conducted pursuant to this section, provided all of the following conditions are met:

- 44 (1) There is no cost or charge to the attendees.
- 45 (2) The employer or trade association obtains a permit and pays the required fee,  
46 as provided in G.S. 14-309.27.
- 47 (3) The game night event is held at a qualified facility.

48 (b) Game night events conducted pursuant to this section shall be subject to the  
49 limitations of G.S. 14-309.28, 14-309.29(a), and 14-309.30.

50 (c) For purposes of this section, any reference to "exempt organization" in  
51 G.S. 14-309.27 shall include the employer or trade association submitting an application as

1 required by this section, except that the verification required by subdivisions (3) and (4) of  
2 subsection (b) of G.S. 14-309.27 shall not be required from an applicant for a permit if the  
3 applicant is required to obtain the permit pursuant to subsection (a) of this section.

4 (d) If any employer or trade association conducts a game night in violation of any  
5 provision of this section, the person indicated in G.S. 14-309.27(b)(2) is guilty of a Class 2  
6 misdemeanor. In addition to any fine that may be imposed, the employer or trade association  
7 convicted of a violation of this section shall not conduct a game night for a period of one year  
8 from the date of the conviction.

9 **"§ 14-309.35. Registration, possession, and transportation of gaming equipment.**

10 (a) Notwithstanding the provisions of G.S. 14-295 or G.S. 14-297, it shall be lawful to  
11 possess or transport gaming tables and other gaming equipment, if the possession or  
12 transportation is solely for use in game night events conducted pursuant to this Part. Gaming  
13 tables and other gaming equipment possessed or transported pursuant to this Part shall not be  
14 subject to seizure pursuant to G.S. 14-298 if they have been registered pursuant to the provisions  
15 of this Article and are used solely in game night events conducted pursuant to this Part.

16 (b) A gaming table or other gaming equipment possessed or transported for use in a game  
17 night event must be registered with the Alcohol Law Enforcement Branch of the Department of  
18 Public Safety and must have a sticker affixed with a unique number. A fee of twenty-five dollars  
19 (\$25.00) shall be charged for each sticker and each sticker shall be renewed annually. The sticker  
20 fees assessed under this section are payable to the Alcohol Law Enforcement Branch of the  
21 Department of Public Safety and shall be collected and used by the Alcohol Law Enforcement  
22 Branch to defray the costs of registering the gaming tables and gaming equipment. The Alcohol  
23 Law Enforcement Branch may inspect, without prior notice, any gaming table or other gaming  
24 equipment used in a game night event at any time immediately prior to or during the game night  
25 event. Use of a gaming table or gaming equipment in a game night event that does not comply  
26 with the requirements of this subsection shall be a Class 1 misdemeanor.

27 **"§ 14-309.36. Permit procedure for game night vendors.**

28 (a) No person, firm, or corporation may receive compensation for providing gaming  
29 tables or gaming equipment for use in a game night without first obtaining a permit as provided  
30 by this section. The application for a game night vendor permit shall be on a form prescribed by  
31 the Alcohol Law Enforcement Branch of the Department of Public Safety and shall be submitted  
32 to the Alcohol Law Enforcement Headquarters.

33 (b) A fee of two thousand five hundred dollars (\$2,500) shall be charged annually for  
34 each permit. The permit fees assessed under this section are payable to the Alcohol Law  
35 Enforcement Branch of the Department of Public Safety and shall be collected and used by the  
36 Alcohol Law Enforcement Branch to defray the costs of issuing game night vendor permits and  
37 ensuring compliance with this section. The game night vendor permit shall be displayed at any  
38 event the game night vendor conducts.

39 (c) The Alcohol Law Enforcement Branch shall deny a permit to a person, firm, or  
40 corporation that meets any of the following disqualifying conditions:

- 41 (1) Has a conviction for any violation of State or federal gambling laws within  
42 the five years prior to the date of application.
- 43 (2) Has pending charges for any violation of State or federal gambling laws.
- 44 (3) Is subject to an active criminal or civil court order prohibiting involvement in  
45 gambling activities.
- 46 (4) Has a conviction for any felony.

47 (d) A person, firm, or corporation with a game night vendor permit may not employ a  
48 person that meets any of the following disqualifying conditions:

- 49 (1) Has a conviction for any violation of State or federal gambling laws within  
50 the five years prior to the date of employment.
- 51 (2) Has pending charges for any violation of State or federal gambling laws.

1           (3)    Is subject to an active criminal or civil court order prohibiting involvement in  
2                   gambling activities.

3           (4)    Has a conviction for any felony.

4       (e)    All gaming tables and gaming equipment owned or possessed by a game night vendor  
5 must be registered pursuant to G.S. 14-309.35. The Alcohol Law Enforcement Branch of the  
6 Department of Public Safety shall inspect the gaming tables and equipment of each game night  
7 vendor at least one time per calendar year and may conduct any additional inspections reasonably  
8 necessary to ensure compliance with G.S. 14-309.35 and this section. Inspections of gaming  
9 tables and equipment shall occur (i) on the premises of a game night event that the game night  
10 vendor has been employed to conduct, (ii) immediately prior to or during the game night event,  
11 (iii) at locations, times, and dates chosen by the Alcohol Law Enforcement Branch, and (iv)  
12 without prior notice to the game night vendor or any party that has obtained a permit pursuant to  
13 G.S. 14-309.27.

14 **"§ 14-309.37. Slot machines, video gaming machines, electronic sweepstakes machines not**  
15 **authorized.**

16       Nothing in this Part shall be construed to authorize the possession, transportation, or use of  
17 any slot machine, video gaming machine, or electronic machine or device prohibited pursuant to  
18 G.S. 14-304 through 14-309."

19       **SECTION 3.** G.S. 18B-1000 reads as rewritten:

20 **"§ 18B-1000. Definitions concerning establishments.**

21       The following requirements and definitions shall apply to this Chapter:

22       ...

23       (5a)   Qualified facility. – A facility that has any of the following permits:

24           a.    On-premises malt beverage.

25           b.    On-premises unfortified wine.

26           c.    On-premises fortified wine.

27           d.    Mixed beverages.

28       ~~(5a)~~(5b)   Residential private club. – A private club that is located in a privately  
29                   owned, primarily residential and recreational development.

30       ...."

31       **SECTION 4.** The Department of Public Safety shall make a report to the 2020  
32 Regular Session of the General Assembly detailing the administration of game night event  
33 permits, including the total number of applications received by permittee type, the total number  
34 of permits issued, the number of ABC violations reported at establishments that hosted game  
35 night events, and any other information the Department deems appropriate to report regarding  
36 this act, and shall provide a recommendation as to whether the General Assembly should modify  
37 this act. If the recommendation is to modify this act, the Department of Public Safety shall submit  
38 recommended proposed legislation to the 2020 Regular Session of the General Assembly.

39       **SECTION 5.** This act becomes effective May 1, 2019. If a final order by a court of  
40 competent jurisdiction finds that any portion of Sections 1 through 4 of this act is  
41 unconstitutional, or if the passage of Sections 1 through 4 of this act would cause the State to  
42 forfeit payments due under a compact entered into between the State and a federally recognized  
43 Indian tribe, Sections 1 through 4 of this act are void.
