HOUSE BILL DRH30405-LGa-142

Short Title: Funds/Youth Villages and Other Purposes. (Public)

1 A BILL TO BE ENTITLED
2 AN ACT TO REVISE PROVISIONS PERTAINING TO THE SUCCESSFUL TRANSITION
3 OF YOUTH IN FOSTER CARE AND TO APPROPRIATE FUNDS FOR THAT PURPOSE
4 AND TO APPROPRIATE FUNDS FOR VARIOUS OTHER PUBLIC PURPOSES.

5 The General Assembly of North Carolina enacts:

6 **SECTION 1.(a)** Section 11C.9(a) of S.L. 2017-57 reads as rewritten:

7 **"SECTION 11C.9.(a)** There is created the Foster Care Transitional Living Initiative Fund
8 to fund and support evidence-based transitional living services that demonstrate positive
9 outcomes for youth, attract significant private sector funding, and ~~lead to the development of~~
10 ~~evidence-based programs~~ advance clinical research to serve the at-risk population described in
11 this section. The Fund shall support a demonstration project with services provided by Youth
12 Villages to (i) improve outcomes for youth ages 17-21 years who transition from foster care
13 through implementation of ~~outcome-based~~ evidence-based Transitional Living Services, (ii)
14 identify cost-savings in social services and juvenile and adult correction services associated with
15 the provision of Transitional Living Services to youth aging out of foster care, and (iii) take
16 necessary steps to establish and maintain an evidence-based transitional living program available
17 to all youth aging out of foster care. In implementing these goals, the Foster Care Transitional
18 Living Initiative Fund shall support the following strategies:

- 19 (1) Transitional Living Services, which is an ~~outcome-based~~ evidence-based
20 program that follows the Youth Villages Transitional Living Model. Outcomes on more than 7,000 participants have been tracked since the
21 program's inception. The program has been evaluated through an independent
22 Randomized Controlled Trial. Results indicate that Youth Villages
23 Transitional Living Model had positive impacts in a variety of areas, including
24 housing stability, earnings, economic hardship, mental health, and intimate
25 partner violence in comparison to the control population.

27 (2) Public-Private Partnership, which is a commitment by private-sector funding
28 partners to match at least fifty percent (50%) of the funds appropriated to the
29 Foster Care Transitional Living Initiative Fund for the ~~2017-2019~~ 2019-2021
30 fiscal biennium for the purposes of providing Transitional Living Services
31 through the Youth Villages Transitional Living Model to youth aging out of
32 foster care.
33 (3) Impact Measurement and Evaluation, which are services funded through
34 private partners to provide independent measurement and evaluation of the
35 impact the Youth Villages Transitional Living Model has on the youth served,

1 the foster care system, and on other programs and services provided by the
2 State which are utilized by former foster care youth.

- 3 (4) Advancement of Evidence-Based Process, which is the implementation and
4 ongoing evaluation of the Youth Villages Transitional Living Model for the
5 purposes of establishing and implementing the first evidence-based
6 transitional living program in the nation. To establish the evidence-based
7 program, additional randomized controlled trials may be conducted to
8 advance the model."

9 **SECTION 1.(b)** There is appropriated from the General Fund to the Department of
10 Health and Human Services, Division of Social Services, the sum of five hundred thousand
11 dollars (\$500,000) recurring, in additional funds, for each year of the 2019-2021 fiscal biennium
12 for the continued implementation of the Foster Care Transitional Living Initiative Fund as
13 described under Section 1 of this act.

14 **SECTION 2.** There is appropriated from the General Fund to the Department of
15 Natural and Cultural Resources the sum of three hundred fifty thousand dollars (\$350,000) in
16 recurring funds for each year of the 2019-2021 fiscal biennium to support the North Carolina
17 Symphony. These funds shall be in addition to any other funds appropriated for the North
18 Carolina Symphony. Of these funds, the sum of fifty thousand dollars (\$50,000) shall be used to
19 provide access to North Carolina Symphony performances for public schools without
20 transportation.

21 **SECTION 3.** There is appropriated from the General Fund to the Department of
22 Commerce the sum of two hundred fifty thousand dollars (\$250,000) in recurring funds for each
23 year of the 2019-2021 fiscal biennium to be allocated to Prospera, a Latino small business
24 outreach program in Charlotte, to provide technical assistance to underserved small businesses in
25 the State of North Carolina.

26 **SECTION 4.** There is appropriated from the General Fund to the Board of Governors
27 of The University of North Carolina the sum of four million five hundred thousand dollars
28 (\$4,500,000) in nonrecurring funds for renovation of the Cameron and Burson buildings at the
29 University of North Carolina at Charlotte.

30 **SECTION 5.** There is appropriated from the General Fund to the Department of
31 Natural and Cultural Resources the sum of five million dollars (\$5,000,000) in recurring funds
32 for each year of the 2019-2021 fiscal biennium to increase the funding for the Aid to Public
33 Libraries Fund.

34 **SECTION 6.** There is appropriated from the General Fund to the Department of
35 Natural and Cultural Resources the sum of two hundred fifty thousand dollars (\$250,000) in
36 nonrecurring funds for the 2019-2020 fiscal year for the NC Kids Digital Library program.

37 **SECTION 7.** This act becomes effective July 1, 2019.
