1 Moves to amend the bill on page 226, lines 14 and 15, by inserting the following between the  
2 lines:

3 **"INNOVATIVE COURT PILOT PROJECT/RAISE THE AGE ADMINISTRATIVE**  
4 **SUPPORT FUNDS**

5 **SECTION 15.7.(a)** Of the funds appropriated in this act to the Administrative Office  
6 of the Courts in Fund Code 1100, the Administrative Office of the Courts shall provide the sum  
7 of one hundred thirty thousand dollars (\$130,000) in nonrecurring funds for each fiscal year of  
8 the 2019-2021 fiscal biennium to Robeson County as a grant-in-aid to be used for an innovative  
9 court pilot project.

10 **SECTION 15.7.(b)** The Administrative Office of the Courts, in conjunction with  
11 Robeson County, shall report on the results of the innovative court pilot project required under  
12 subsection (a) of this section to the chairs of the Joint Legislative Oversight Committee on Justice  
13 and Public Safety by March 1, 2020.

14 **SECTION 15.7.(c)** Notwithstanding any provision of this act or the Committee  
15 Report described in Section 42.2 of this act to the contrary, all of the following applies:

- 16 (1) The net appropriation to Fund Code 1200 for Raise the Age Administrative  
17 Support shall be reduced by (i) the sum of one hundred thirty thousand dollars  
18 (\$130,000) in nonrecurring funds for the 2019-2020 fiscal year and (ii) the  
19 sum of one hundred thirty thousand dollars (\$130,000) in recurring funds for  
20 the 2020-2021 fiscal year.
- 21 (2) The net appropriation to Fund Code 1100 for the Administrative Office of the  
22 Courts Administration shall be increased by (i) the sum of one hundred thirty  
23 thousand dollars (\$130,000) in nonrecurring funds for the 2019-2020 fiscal  
24 year and (ii) the sum of one hundred thirty thousand dollars (\$130,000) in  
25 recurring funds for the 2020-2021 fiscal year."; and

27 by adjusting the appropriate totals accordingly.
