9 **SECTION 40.24.** Notwithstanding any other provision of this act to the contrary, of
10 the funds appropriated to the Highway Fund, Reserves, Transfers, and Other the sum of four
11 million nine hundred fifty-eight thousand eight hundred eighty-one dollars (\$4,958,881) for the
12 2019-2020 fiscal year and fourteen million nine hundred two thousand nine hundred eighty five
13 dollars (\$14,902,985) for the 2020-2021 fiscal year shall be allocated as follows:

- 14 (1) Nine hundred eighty-seven thousand four hundred twenty-one dollars
15 (\$987,421) for the 2019-2020 fiscal year and three million six hundred sixty-
16 six thousand two hundred seven dollars (\$3,662,207) for the 2020-2021 fiscal
17 year in recurring funds for increased employer costs of the health benefit
18 coverage for active employees utilizing the State Health Plan.
- 19 (2) Three million eight hundred thousand two hundred seventy-six dollars
20 (\$3,800,276) for the 2019-2020 fiscal year and ten million ninety-nine
21 thousand eight hundred thirty-two dollars (\$10,099,832) for the 2020-2021
22 fiscal year in recurring funds for the actuarially determined contribution and
23 increased retiree medical premiums, and a one percent (1.0%) one-time cost-
24 of-living supplement to retirees in FY 2020-21 in the amount of nine hundred
25 sixty-nine thousand seven hundred sixty-two dollars (\$969,762).
- 26 (3) One hundred seventy-one thousand one hundred eighty-four dollars
27 (\$171,184) in recurring funds for each year of the 2019-2021 biennium for the
28 payment of short-term disability benefits."; and

30 on page 124, line 32, through page 139, line 41, by re-designating Section 9B.9 as Section 9G.10
31 and moving it to Part IX-G; and

7 **SECTION 5.7.** Of the funds appropriated in this act, the sum of four hundred
8 thousand dollars (\$400,000) for the 2019-2010 fiscal year shall be transferred from the OSHR
9 Minimum of Market Reserve and the sum of three hundred fifty thousand dollars (\$350,000) for
10 the 2019-2020 fiscal year shall be transferred from the Pending Legislation Reserve, to the 2020
11 Census Preparation Reserve (Reserve) created in this section. The seven hundred fifty thousand
12 dollars (\$750,000) in the Reserve shall be managed by the Office of State Budget and
13 Management and used for materials and outreach related to statewide preparation for the 2020
14 United States Census."; and
