1 moves to amend the bill on page 184, lines 48-49,
2 by inserting the following new section between those lines to read:

4 **"ANNUAL REPORT/CERTAIN TANF EXPENDITURES**

5 **SECTION 9L.16.(a)** Recurring funds appropriated in this act to the Department of
6 Health and Human Services, Division of Health Benefits, for each year of the 2019-2021 fiscal
7 biennium for the Group Home Wage Increase (1310) shall be decreased by the sum of five
8 thousand dollars (\$5,000) and recurring funds appropriated in this act to the Division of Social
9 Services shall be increased by the sum of five thousand dollars (\$5,000) for each year of the
10 2019-2021 fiscal biennium and shall be used for the Division to report and post on its Web site
11 and make available by June 30 and December 31 of each year to the Joint Legislative Oversight
12 Committee on Health and Human Services, the Speaker of the House of Representatives, the
13 House of Representatives Minority Leader, the President of the Senate, and the Senate Minority
14 Leader a report on certain expenditures for the Temporary Assistance for Needy Families
15 (TANF) program. The report, at a minimum, shall include each of the following:

- 16 (1) The dollar amount and number of transactions of TANF benefits accessed or
17 expended out-of-state, by state.
- 18 (2) The dollar amount, number of transactions, and times of transactions of TANF
19 benefits accessed or expended in this State, by retailer, institution, or location.

20 **SECTION 9L.16.(b)** The Division shall maintain the confidentiality of information
21 not public under Chapter 132 of the General Statutes. The Division shall properly redact any
22 information subject to reporting under subsection (a) of this section to prevent identification of
23 individual recipients of TANF benefits."; and
