26 (3) Determining, in conjunction with the agency fiscal officer, the budgetary
27 impact of a suggestion or innovation.

28 (4) Judging impartially both the positive and negative effects of a suggestion or
29 innovation on the current functions of the subject program, activity, or service.

30 (d) The Director of the Office of State Human Resources shall be responsible for general
31 oversight and coordination of NC-Thinks. The State coordinator shall be an employee of the
32 Office of State Human Resources. The State coordinator shall be responsible for day-to-day
