15 program, a foster care program for children who are ages  
16 0 to 10 who are not in the custody of the Department of  
17 Social Services and whose families are temporarily unable  
18 to care for them because of a crisis, and allows  
19 the sibling of a child in the Angel Watch program who is  
20 older than 10 years of age, but under 18 years of age,  
21 to also participate in the program. Children are placed  
22 in a licensed Angel Care foster home for up to  
23 90 days while the family attempts to resolve the issue  
24 that keeps them from safely caring for their children.  
25 Parents are provided mentoring and links to community  
26 resources by program managers and foster parents.; and
