Senator Marcus

1 moves to amend the bill on page 153, lines 29-30, by inserting between the lines the following  
2 new section to read:

3 **"FUNDS FOR MATERNAL AND CHILD HEALTH PROGRAMS**

4 **SECTION 9G.4A.(a)** Notwithstanding any provision of this act to the contrary, (i)  
5 funds appropriated for a directed grant to Mountain Area Pregnancy Services are reduced by one  
6 hundred thousand dollars (\$100,000) in nonrecurring funds for each year of the 2019-2021 fiscal  
7 biennium; (ii) funds appropriated for Carolina Pregnancy Care Fellowship are reduced by four  
8 hundred thousand dollars (\$400,000) in recurring funds for each year of the 2019-2021 fiscal  
9 biennium; and (iii) funds appropriated to the Human Coalition for statewide expansion of the  
10 continuum of care pilot program are reduced by one million two hundred thousand dollars  
11 (\$1,200,000) in nonrecurring funds for each year of the 2019-2021 fiscal biennium.

12 **SECTION 9G.4A.(b)** Of the funds appropriated in this act to the Department of  
13 Health and Human Services, Division of Public Health, the sum of one million three hundred  
14 thousand dollars (\$1,300,000) in nonrecurring funds and four hundred thousand dollars  
15 (\$400,000) in recurring funds for the 2019-2020 fiscal year and the sum of one million three  
16 hundred thousand dollars (\$1,300,000) in nonrecurring funds and four hundred thousand dollars  
17 (\$400,000) in recurring funds for the 2020-2021 fiscal year shall be allocated to fund  
18 evidence-based maternal and child health programs administered by the Division of Public  
19 Health."; and

21 further moves to amend the bill on page 153, lines 31-43; and page 154, line 7 through page 155,  
22 line 13, by deleting the lines; and

24 by adjusting the appropriate totals accordingly.
