1 A BILL TO BE ENTITLED
2 AN ACT AUTHORIZING THE BURLINGTON-ALAMANCE AIRPORT AUTHORITY TO
3 ENTER INTO LEASES AND CONTRACTS WITH TERMS NOT TO EXCEED FORTY
4 YEARS.

5 The General Assembly of North Carolina enacts:

6 SECTION 1. Section 4 of S.L. 1969-814, as amended by S.L. 1971-263, reads as
7 rewritten:

8 "Sec. 4. The said Airport Authority shall constitute a body, both corporate and politic, and
9 shall have the following powers and authority:

10 ...

11 (11) To lease (without the joinder in the lease agreements of the owning
12 municipalities, to-wit, the County of Alamance and the City of Burlington) for a term not to
13 exceed ~~twenty five (25) years,~~ forty (40) years, and for purposes not inconsistent with the grants
14 and agreements under which the said airport is held by said owning municipalities, real or
15 personal property under the supervision of or administered by the said Authority.

16 (12) To contract with persons, firms or corporations for terms not to exceed ~~twenty-~~
17 ~~five (25) years,~~ forty (40) years, for the operation of airline-scheduled passenger and freight
18 flights, non-scheduled flights, and any other airplane activities not inconsistent with said grant
19 agreements under which the airport property is held by the owning municipal corporations, and
20 to charge and collect reasonable and adequate fees, charges and rents for the use of such property
21 or for services rendered in the operation thereof.

22 (13) To erect and construct buildings, hangars, shops and other improvements and
23 facilities, not inconsistent with or in violation of the agreements applicable to and the grants
24 under which the real property of the airport is held; to lease the same for a term or terms not to
25 exceed ~~twenty five (25) years;~~ forty (40) years; to borrow money for use in making or paying for
26 such improvements and facilities, secured by and on the credit only of the lease agreements in
27 respect thereto, to pledge and assign such leases and lease agreements as security for loans herein
28 authorized."

29 SECTION 2. This act is effective when it becomes law and applies to contracts
30 entered into, renewed, or modified on or after that date.
