17 plate under this subdivision for the registered owner of a motor vehicle or a  
18 motorcycle. The division may not issue a plate authorized under this  
19 subdivision until it receives at least 350 applications for the plate.  
20 Applications for motor vehicle special registration plates and motorcycle  
21 special registration plates received by the Division each count towards the  
22 minimum number of applications necessary to issue a plate under this  
23 subdivision."; and
