7 **PART I. ALLOCATION OF ASSISTANT DISTRICT ATTORNEYS**

8 **SECTION 1.(a)** G.S. 7A-60(a1) reads as rewritten:

**SECTION 2.(b)** Section 2(b) of S.L. 2018-14 reads as rewritten:

**"SECTION 2.(b)** In order to implement the district court districts as enacted by this section, the following shall apply:

(1) Judges in the following districts, as set out in this section, shall take office on January 1, 2019, with elections in 2018, and every four years thereafter, to be held accordingly:

a. District 10A – one judge.

- 1 b. District 10B – one judge.  
2 c. District 10D – three judges.  
3 d. District 10E – two judges.  
4 e. District 10F – one judge.  
5 f. District 26A – three judges.  
6 g. District 26B – one judge.  
7 h. District 26E – two judges.  
8 i. District 26F – two judges.  
9 j. District 26G – one judge.  
10 (2) Judges in the following districts, as set out in this section, shall take office on  
11 January 1, 2021, with elections in 2020, and every four years thereafter, to be  
12 held accordingly:  
13 a. District 10A – two judges.  
14 b. District 10B – two judges.  
15 c. District 10C – three judges.  
16 d. District 10D – ~~three~~ two judges.  
17 e. District 10E – one judge.  
18 f. District 10F – two judges.  
19 g. District 26B – two judges.  
20 h. District 26C – two judges.  
21 i. District 26D – two judges.  
22 j. District 26E – one judge.  
23 k. District 26F – one judge.  
24 l. District 26G – one judge.  
25 m. District 26H – three judges."

26 **SECTION 2.(c)** Subsection (b) of this section becomes effective July 1, 2019.  
27 Subsection (a) of this section becomes effective January 1, 2021, and elections conducted in 2020  
28 shall be conducted in accordance with the judgeships created in subsection (a) of this section.

### 30 **PART III. APPROPRIATIONS TO THE ADMINISTRATIVE OFFICE OF THE** 31 **COURTS**

32 **SECTION 3.(a)** To support implementation of Section 16D.4 of S.L. 2017-57  
33 ("Raise the Age legislation"), there is appropriated from the General Fund to the Administrative  
34 Office of the Courts the sum of three hundred seventy-three thousand one hundred ninety-one  
35 dollars (\$373,191) in recurring funds for the 2019-2020 fiscal year, the sum of sixteen thousand  
36 ninety-three dollars (\$16,093) in nonrecurring funds for the 2019-2020 fiscal year, the sum of  
37 one million three hundred sixty-six thousand one hundred thirty-one dollars (\$1,366,131) in  
38 recurring funds for the 2020-2021 fiscal year, and the sum of sixty-nine thousand five hundred  
39 three dollars (\$69,503) in nonrecurring funds for the 2020-2021 fiscal year, to be used for all of  
40 the following:

- 41 (1) Create seven deputy clerk positions, effective July 1, 2019. The positions  
42 authorized under this subdivision shall be located in the Counties of  
43 Alamance, Burke, Davidson, Johnston, McDowell, Randolph, and Yadkin.  
44 (2) Create seven district court judge positions, effective January 1, 2021.

45 **SECTION 3.(b)** To support implementation of the Raise the Age legislation, there  
46 is appropriated from the General Fund to the Administrative Office of the Courts the sum of one  
47 million three hundred thirty-two thousand two hundred fifty-two dollars (\$1,332,252) in  
48 recurring funds for each fiscal year of the 2019-2021 fiscal biennium, and the sum of forty-six  
49 thousand three hundred sixty-two dollars (\$46,362) in nonrecurring funds for the 2019-2020  
50 fiscal year, to be used to create nine assistant district attorney positions and three district attorney  
51 legal assistant positions. The positions authorized under this subsection are effective July 1, 2019.

1 The legal assistant positions authorized under this subsection shall be assigned to Prosecutorial  
2 District 28 (Stanley and Montgomery Counties), Prosecutorial District 33 (Davie and Davidson  
3 Counties), and Prosecutorial District 36 (Burke, Caldwell, and Catawba Counties).

4 **SECTION 3.(c)** To support implementation of the Raise the Age legislation, there  
5 is appropriated from the General Fund to the Administrative Office of the Courts the sum of eight  
6 hundred seventy-nine thousand one hundred twenty-three dollars (\$879,123) in recurring funds  
7 for the 2020-2021 fiscal year to be used to create seven assistant district attorney positions  
8 starting in the 2020-2021 fiscal year to address existing deficiencies in district attorney office  
9 workload.

#### 10 **PART IV. APPROPRIATION TO THE OFFICE OF INDIGENT DEFENSE SERVICES**

11 **SECTION 4.** To support implementation of the Raise the Age legislation, there is  
12 appropriated from the General Fund to the Office of Indigent Defense Services the sum of  
13 eighty-seven thousand six hundred eighty-one dollars (\$87,681) in recurring funds for the  
14 2019-2020 fiscal year, and the sum of one hundred nine thousand one hundred thirty-one dollars  
15 (\$109,131) in recurring funds for the 2020-2021 fiscal year, to be used to create a position,  
16 effective October 1, 2019, to provide training and consulting services to private assigned counsel  
17 attorneys in the State assigned to juvenile justice cases.

#### 18 **PART V. APPROPRIATIONS TO THE DEPARTMENT OF PUBLIC SAFETY**

19 **SECTION 5.** To support implementation of the Raise the Age legislation, the sum  
20 of thirty million nine hundred fifteen thousand four hundred thirty-one dollars (\$30,915,431) for  
21 the 2019-2020 fiscal year and the sum of forty-three million five hundred thirty-eight thousand  
22 seven hundred four dollars (\$43,538,704) for the 2020-2021 fiscal year are appropriated from the  
23 General Fund to the Department of Public Safety as follows:

- 24 (1) One million four hundred twenty thousand fifty-three dollars (\$1,420,053) in  
25 recurring funds for the 2019-2020 fiscal year, two hundred thousand dollars  
26 (\$200,000) in nonrecurring funds for the 2019-2020 fiscal year, and one  
27 million eight hundred ninety-three thousand four hundred four dollars  
28 (\$1,893,404) in recurring funds for the 2020-2021 fiscal year, to provide  
29 funding to the Division of Juvenile Justice to create, effective October 1, 2019,  
30 five staff training positions, two statistician positions, three information  
31 technology positions, and two human resources positions.
- 32 (2) Five hundred thousand dollars (\$500,000) in recurring funds for the  
33 2019-2020 fiscal year, forty thousand dollars (\$40,000) in nonrecurring funds  
34 for the 2019-2020 fiscal year, and five hundred thousand dollars (\$500,000)  
35 in recurring funds for the 2020-2021 fiscal year, to be used to create one  
36 facility management position and six field support specialist positions to  
37 support operations at the juvenile detention centers, youth development  
38 centers, and other Division of Juvenile Justice facilities throughout the State.
- 39 (3) Five hundred ninety-three thousand nine hundred eighty-four dollars  
40 (\$593,984) in recurring funds for the 2019-2020 fiscal year, one million  
41 forty-four thousand dollars (\$1,044,000) in nonrecurring funds for the  
42 2019-2020 fiscal year, and eight hundred ninety thousand nine hundred  
43 seventy-six dollars (\$890,976) in recurring funds for the 2020-2021 fiscal  
44 year, to be used to (i) create, effective October 1, 2019, 15 transportation  
45 positions and (ii) purchase 29 vans.
- 46 (4) Four million five hundred thousand dollars (\$4,500,000) in recurring funds  
47 for the 2019-2020 fiscal year and six million seven hundred thousand dollars  
48 (\$6,700,000) in recurring funds for the 2020-2021 fiscal year, to be used to  
49 increase bed capacity at juvenile detention centers. The funds appropriated in  
50  
51

- 1 this subdivision shall be used to support operations at juvenile detention  
2 centers across the State, including those owned and operated by the State and  
3 those owned and operated on a contract basis by certain counties.
- 4 (5) One million five hundred thirty-five thousand four hundred eighty-six dollars  
5 (\$1,535,486) in recurring funds for the 2019-2020 fiscal year, three hundred  
6 twenty-two thousand dollars (\$322,000) in nonrecurring funds for the  
7 2019-2020 fiscal year, and two million three hundred thousand dollars  
8 (\$2,300,000) in recurring funds for the 2020-2021 fiscal year, to create 38  
9 positions at, and cover certain operating expenses for, the C.A. Dillon Youth  
10 Development Center in the Town of Butner.
- 11 (6) Three hundred fifty thousand dollars (\$350,000) in recurring funds for the  
12 2019-2020 fiscal year, twenty-four thousand nine hundred fourteen dollars  
13 (\$24,914) in nonrecurring funds for the 2019-2020 fiscal year, and five  
14 hundred thousand dollars (\$500,000) in recurring funds for the 2020-2021  
15 fiscal year, to create, effective October 1, 2019, four new school counselor  
16 positions to provide reentry and placement services, career planning,  
17 vocational training, and other services for juveniles who are preparing to exit  
18 secure custody.
- 19 (7) Six million five hundred thousand dollars (\$6,500,000) in recurring funds for  
20 the 2019-2020 fiscal year, three hundred fifty thousand dollars (\$350,000) in  
21 nonrecurring funds for the 2019-2020 fiscal year, and eleven million one  
22 hundred thousand dollars (\$11,100,000) in recurring funds for the 2020-2021  
23 fiscal year, to (i) provide additional funding for contracts for Level II  
24 community-based and residential programs for juveniles who have been  
25 adjudicated delinquent and (ii) create, effective December 1, 2019, one  
26 contract management position.
- 27 (8) Two hundred fifty thousand dollars (\$250,000) in recurring funds for the  
28 2019-2020 fiscal year, eighty thousand dollars (\$80,000) in nonrecurring  
29 funds for the 2019-2020 fiscal year, and four hundred thousand dollars  
30 (\$400,000) in recurring funds for the 2020-2021 fiscal year, to create,  
31 effective November 1, 2019, five positions in the Community Programs  
32 section to provide administrative support and technical assistance and to  
33 monitor programmatic quality and fiscal accountability for Juvenile Crime  
34 Prevention Council programs.
- 35 (9) Four million two hundred fifty thousand dollars (\$4,250,000) in recurring  
36 funds for the 2019-2020 fiscal year and six million six hundred sixty-one  
37 thousand nine hundred thirty dollars (\$6,661,930) in recurring funds for the  
38 2020-2021 fiscal year, to provide additional funding to be allocated to the  
39 county-level Juvenile Crime Prevention Councils.
- 40 (10) Three million eighty-two thousand six hundred dollars (\$3,082,600) in  
41 recurring funds for the 2019-2020 fiscal year, one million nine hundred eighty  
42 thousand dollars (\$1,980,000) in nonrecurring funds for the 2019-2020 fiscal  
43 year, and eight million seven hundred thousand dollars (\$8,700,000) in  
44 recurring funds for the 2020-2021 fiscal year, to create, beginning November  
45 1, 2019, and phased in over the course of the 2019-2020 fiscal year, 97  
46 Juvenile Court Counselor positions that will act as the primary point of contact  
47 for juveniles and their families as the juveniles move through the juvenile  
48 justice system.
- 49 (11) Three million eight hundred ninety-two thousand three hundred ninety-four  
50 dollars (\$3,892,394) in recurring funds for the 2019-2020 fiscal year and three  
51 million eight hundred ninety-two thousand three hundred ninety-four dollars

1 (\$3,892,394) in recurring funds for the 2020-2021 fiscal year, to provide  
2 annualized recurring funding for the 65 full-time equivalent (FTE) positions  
3 in the Court Services section of the Division of Juvenile Justice authorized in  
4 the Committee Report described in Section 39.2 of S.L. 2018-5.  
5

6 **PART VI. CONFORMING CHANGES**

7 **SECTION 6.** If House Bill 966, 2019 Regular Session, becomes law, then Sections  
8 15.6 and 15.10 of that act are repealed.  
9

10 **PART VII. MISCELLANEOUS AND EFFECTIVE DATE**

11 **SECTION 7.(a)** Departmental receipts, as defined in G.S. 143C-1-1, are  
12 appropriated for each fiscal year of the 2019-2021 fiscal biennium up to the amounts needed to  
13 implement the provisions set forth in this act.

14 **SECTION 7.(b)** If any provision of this act and G.S. 143C-5-4 are in conflict, the  
15 provisions of this act shall prevail. The appropriations and the authorizations to allocate and  
16 spend funds which are set out in this act shall remain in effect until the Current Operations  
17 Appropriations Act for the applicable fiscal year becomes law, at which time that act shall  
18 become effective and shall govern appropriations and expenditures. When the Current  
19 Operations Appropriations Act for that fiscal year becomes law, the Director of the Budget shall  
20 adjust allotments to give effect to that act from July 1 of the fiscal year.

21 **SECTION 7.(c)** Except as otherwise provided in this act, this act becomes effective  
22 July 1, 2019.
