HOUSE BILL DRH30083-MV-63

Short Title: Allow Coordination of School & CC Calendars. (Public)

1 A BILL TO BE ENTITLED
2 AN ACT TO ALLOW LOCAL BOARDS OF EDUCATION COLLABORATING WITH
3 COMMUNITY COLLEGES TO COORDINATE THEIR SCHOOL CALENDARS WITH
4 THOSE OF THE COMMUNITY COLLEGES.

5 Whereas, the local boards of education should be able to schedule school opening and
6 closing dates for any school in their respective units to coincide with the opening and closing
7 dates of community colleges in serving their communities; and

8 Whereas, school calendar coordination would benefit all students in local school
9 administrative units who are enrolled in community college classes by allowing them to align
10 their fall and spring semesters with the fall and spring semesters at their respective community
11 colleges; and

12 Whereas, school calendar coordination would allow local school administrative units
13 and community colleges to meet the workforce development needs in their respective counties
14 more effectively than the current structure by helping high school and college students develop
15 the skills necessary for business and industry; Now, therefore,
16 The General Assembly of North Carolina enacts:

17 **SECTION 1.** G.S. 115C-84.2(d) reads as rewritten:

18 "(d) Opening and Closing Dates. – Local boards of education shall determine the dates of
19 opening and closing the public schools under subdivision (a)(1) of this section. Except for
20 year-round schools, the opening date for students shall be no earlier than the Monday closest to
21 August 26, and the closing date for students shall be no later than the Friday closest to June 11.
22 On a showing of good cause, the State Board of Education may waive the requirement that the
23 opening date for students be no earlier than the Monday closest to August 26 and may allow the
24 local board of education to set an opening date no earlier than the Monday closest to August 19,
25 to the extent that school calendars are able to provide sufficient days to accommodate anticipated
26 makeup days due to school closings. A local board may revise the scheduled closing date if
27 necessary in order to comply with the minimum requirements for instructional days or
28 instructional time. For purposes of this subsection, the term "good cause" means that schools in
29 any local school administrative unit in a county have been closed eight days per year during any
30 four of the last 10 years because of severe weather conditions, energy shortages, power failures,
31 or other emergency situations.

32 The required opening and closing dates under this subsection shall not apply to any school
33 that a local board designated as having a modified calendar for the 2003-2004 school year or to
34 any school that was part of a planned program in the 2003-2004 school year for a system of
35 modified calendar schools, so long as the school operates under a modified calendar.



1 Notwithstanding the required opening and closing dates under this subsection, a local school
2 administrative unit collaborating with a local community college pursuant to G.S. 115D-20(4)
3 and consistent with State Board of Community Colleges Code 1G SBCCC 200.93(a) as effective
4 December 1, 2018, may align the calendar of schools in the local school administrative unit with
5 the calendar of the local community college with which it is collaborating."

6 **SECTION 2.** This act is effective when it becomes law and applies beginning with
7 the 2019-2020 school year.
