1 A BILL TO BE ENTITLED
2 AN ACT TO APPOINT PERSONS TO VARIOUS PUBLIC OFFICES UPON THE
3 RECOMMENDATION OF THE SPEAKER OF THE HOUSE OF REPRESENTATIVES
4 AND PRESIDENT PRO TEMPORE OF THE SENATE.

5 Whereas, G.S. 120-121 authorizes the General Assembly to make certain
6 appointments to public offices upon the recommendation of the Speaker of the House of
7 Representatives and President Pro Tempore of the Senate; and

8 Whereas, the Speaker of the House of Representatives and the President Pro Tempore
9 of the Senate have made recommendations; Now, therefore,
10 The General Assembly of North Carolina enacts:

12 **PART I. SPEAKER'S RECOMMENDATIONS**

13 **SECTION 1.1.** Melanie A. Neal of Guilford County is appointed to the 911 Board
14 for a term expiring on December 31, 2022, to fill the unexpired term of Michael Reitz.

15 **SECTION 1.2.** Todd B. Bennett of Cabarrus County is appointed to the North
16 Carolina Brain Injury Advisory Council for a term expiring on September 30, 2020, to fill the
17 unexpired term of Dr. Mary Collier.

18 **SECTION 1.3.** Hilda A. Parlér of Franklin County is appointed to the Charter School
19 Advisory Committee for a term expiring on June 30, 2021, to fill the unexpired term of Lindalyn
20 Kakadelis.

21 **SECTION 1.4.** Paul J. Cozza of New Hanover County is appointed to the Ferry
22 Transportation Authority for a term expiring on June 30, 2021, to fill the unexpired term of
23 Bradford T. Smith.

24 **SECTION 1.5.** The Honorable Darrell McCormick of Yadkin County is appointed
