A BILL TO BE ENTITLED AN ACT TO ALLOW RURAL CENSUS TRACTS OF TIER THREE COUNTIES TO BE ELIGIBLE FOR UTILITY ACCOUNT FUNDS. The General Assembly of North Carolina enacts: SECTION 1. G.S. 143B-437.01 reads as rewritten: "§ 143B-437.01. Industrial Development Fund Utility Account.		
(a) Cr special accor Account") to distressed cor providing for	reation and Purpose of Fund. – There is created in the Department of Comment to be known as the Industrial Development Fund Utility Account ("o provide funds to assist the local government units of the most economunities in the State in creating jobs. The Department of Commerce shall adoper the administration of the program. Those rules shall include the followhich shall apply to each grant from the account: The funds shall be used for construction of or improvements to new or exwater, sewer, gas, telecommunications, high-speed broadband, eleutility distribution lines or equipment, or transportation infrastructure existing or new or proposed buildings. To be eligible for funding, the gas, telecommunications, high-speed broadband, electrical utility line facilities, or transportation infrastructure shall be located on the site building or, if not located on the site, shall be directly related to the open of the job creation activity. To be eligible for funding, the sewer infrastructure is located in a county other than the county in whit building is located. The funds shall be used for projects located in economically disting counties except that the Secretary of Commerce may use up to one himself. There shall be no local match requirement if the project is located in a county that has one of the 25 highest rankings under G.S. 143B-437.08.

The funds shall not be used for any retail, entertainment, or sports projects. The funds shall not be used for any nonmanufacturing project that does not meet the wage standard for the development tier area or zone in which the project is located. There is no wage standard for a development tier one area. If an urban progress zone or an agrarian growth zone is not in a development tier one area, then the wage standard for that zone is an average weekly wage that is at least equal to ninety percent (90%) of the lesser of the average wage for all insured private employers in the State and the average wage for all insured private employers in the county in which the project is located. The wage standard for a development tier two area or a development tier three area is an average weekly wage that is at least equal to one hundred ten percent (110%) of the lesser of the average wage for all insured private employers in the State and ninety percent (90%) of the average wage for all insured private employers in the county in which the project is located.

(7) Priority for the use of funds shall be given to eligible industries.

(a1) Definitions. – The following definitions apply in this section:

(4) Economically distressed county. – A county that is defined as a development tier one or two area has one of the 87 highest rankings under G.S. 143B-437.08.

(7) Major economic dislocation. – The actual or imminent loss of 500 or more manufacturing jobs in the county or of a number of manufacturing jobs equal to at least ten percent (10%) of the existing manufacturing workforce in the county.
