HOUSE BILL DRH40620-MVa-190A

Short Title: Funds For Educational Entities/COVID. (Public)

Sponsors: Representatives Fraley, Clemmons, and Horn (Primary Sponsors).

Referred to:

1 A BILL TO BE ENTITLED
2 AN ACT TO APPROPRIATE FUNDS TO EDUCATIONAL ENTITIES IN RESPONSE TO
3 THE CORONAVIRUS DISEASE 2019 (COVID-19) CRISIS.

4 The General Assembly of North Carolina enacts:

5 **SECTION 1.** Transfer of Funds from Reserves to Relief Fund. – The State Controller
6 shall transfer a sum sufficient to accomplish the purposes provided in Section 3 of this act for the
7 2019-2020 fiscal year from the Coronavirus Relief Reserve established in Section 2.1 of S.L.
8 2020-4 to the Coronavirus Relief Fund established in Section 2.2 of S.L. 2020-4.

9 **SECTION 2.** Appropriation of Funds from Relief Fund. – There is appropriated from
10 the Coronavirus Relief Fund to the Office of State Budget and Management the sum sufficient
11 described in Section 1 of this act in nonrecurring funds for the 2019-2020 fiscal year to be
12 allocated and used as provided in Section 3 of this act. The funds appropriated in this section
13 shall not revert at the end of the 2019-2020 fiscal year but shall remain available to expend until
14 December 30, 2020.

15 **SECTION 3.** Allocations of Funds. – The Office of State Budget and Management
16 shall allocate the funds appropriated in Section 2 of this act as follows:

- 17 (1) A portion of the sum sufficient described in this act to the Department of
18 Public Instruction to provide services and cover costs necessary to assist
19 schools and students affected by COVID-19.
20 (2) A portion of the sum sufficient described in this act to the Community
21 Colleges System Office to provide services and cover costs necessary to assist
22 community colleges and students affected by COVID-19.
23 (3) A portion of the sum sufficient described in this act to the Board of Governors
24 of The University of North Carolina to provide services and cover costs
25 necessary to assist constituent institutions and students affected by
26 COVID-19.
27 (4) A portion of the sum sufficient described in this act to the Board of Governors
28 of The University of North Carolina to be allocated to the State Education
29 Assistance Authority to provide services and cover costs necessary to assist
30 eligible private postsecondary institutions, as defined in G.S. 116-280(3), and
31 students affected by COVID-19.

32 **SECTION 4.** This act is effective when it becomes law.
