HOUSE BILL DRH10829-LUa-185

Short Title: Ensure Awareness of Assistance Programs/COVID. (Public)

1 A BILL TO BE ENTITLED  
2 AN ACT TO APPROPRIATE FUNDS FROM THE CORONAVIRUS RELIEF FUND UNDER  
3 THE CORONAVIRUS AID, RELIEF, AND ECONOMIC SECURITY (CARES) ACT TO  
4 ENSURE THAT CHILDREN AND FAMILIES ARE CONNECTED TO ALL  
5 FEDERALLY FUNDED ASSISTANCE PROGRAMS FOR WHICH THEY ARE  
6 ELIGIBLE DURING THE COVID-19 PANDEMIC.

7 The General Assembly of North Carolina enacts:

8 **SECTION 1.(a)** The State Controller shall transfer the sum of two million dollars  
9 (\$2,000,000) for the 2020-2021 fiscal year from the Coronavirus Relief Reserve established  
10 under Section 2.1 of S.L. 2020-4 to the Coronavirus Relief Fund under the Coronavirus Aid,  
11 Relief, and Economic Security (CARES) Act of 2020, P.L. 116-136, established in Section 2.2  
12 of that act.

13 **SECTION 1.(b)** There is appropriated from the Coronavirus Relief Fund to the  
14 Department of Health and Human Services (Department) the sum of two million dollars  
15 (\$2,000,000) in nonrecurring funds for the 2020-2021 fiscal year to ensure that children and  
16 families are connected to all federally funded public assistance programs for which they are  
17 eligible by providing funding for the following:

- 18 (1) Data matching to identify, contact, and enroll children and families who are  
19 currently enrolled in one program, including unemployment insurance  
20 benefits, who are eligible or newly eligible for multiple programs.
- 21 (2) Investment in technology and temporary staffing to support the work required  
22 under subdivision (1) of this section and the work of enrolling families who  
23 are in urgent need of assistance due to the COVID-19 pandemic who have  
24 never interacted with the Department of Health and Human Services, Division  
25 of Social Services.
- 26 (3) Capacity for a public-focused awareness campaign to encourage enrollment  
27 in federally funded benefits programs for families who are newly eligible due  
28 to the COVID-19 pandemic, as well as guidance on how to enroll in those  
29 programs.

30 **SECTION 1.(c)** The funds provided under this section shall be used for the purposes  
31 described in this section and the requirements and limitations set forth in the CARES Act.

32 **SECTION 2.** The Department of Health and Human Services shall provide a report  
33 to the House Appropriations Committee on Health and Human Services, the Senate  
34 Appropriations Committee on Health and Human Services, and the Fiscal Research Division by  
35 March 1, 2021, detailing the use of funds allocated under this act.

1                   **SECTION 3.** This act becomes effective July 1, 2020, and applies retroactively to  
2 March 1, 2020, and expires December 30, 2020.
