2 AN ACT TO IMPROVE VIABILITY OF THE WATER AND WASTEWATER SYSTEMS OF
3 CERTAIN UNITS OF LOCAL GOVERNMENT BY REQUIRING LOCAL
4 GOVERNMENT COMMISSION APPROVAL OF GRANT APPLICATIONS; TO
5 REQUIRE CERTAIN WATER AND WASTEWATER SYSTEMS TO UNDERGO A
6 REVIEW OF INFRASTRUCTURE MANAGEMENT, ORGANIZATIONAL
7 MANAGEMENT, AND FINANCIAL MANAGEMENT; TO CREATE AND PROVIDE
8 FUNDING FOR THE VIABLE UTILITY RESERVE TO PROVIDE GRANT MONEY
9 FOR LOCAL GOVERNMENT UNITS; TO PROVIDE A STATUTORY PROCESS FOR
10 MERGER AND DISSOLUTION OF WATER AND WASTEWATER SYSTEMS
11 ESTABLISHED UNDER CHAPTER 162A OF THE GENERAL STATUTES; TO
12 PROMOTE THE IMPORTANCE OF INTERLOCAL AGREEMENTS TO THE
13 OPERATION OF WATER AND WASTEWATER SYSTEMS; TO STUDY SUBBASIN
14 TRANSFERS AND HISTORICAL CHARTERS; AND TO PROVIDE FUNDS FOR THE
15 SOUTHERN REGIONAL AREA HEALTH EDUCATION CENTER.

16 The General Assembly of North Carolina enacts:

18 **PART I. REFORM OF WATER AND WASTEWATER PUBLIC ENTERPRISES**

19 **SECTION 1.(a)** G.S. 159G-20 reads as rewritten:

20 **"§ 159G-20. Definitions.**

21 The following definitions apply in this Chapter:

22 ...

23 (4a) Distressed unit. – A public water system or wastewater system operated by a
24 local government unit exhibiting signs of failure to identify or address those
25 financial or operating needs necessary to enable that system to become or to
26 remain a local government unit generating sufficient revenues to adequately
27 fund management and operations, personnel, appropriate levels of
28 maintenance, and reinvestment that facilitate the provision of reliable water
29 or wastewater services.

30 ...

31 (13) Local government unit. – Any of the following:

- 32 a. A city as defined in G.S. 160A-1.
33 b. A county.
34 c. A consolidated city-county as defined in G.S. 160B-2.

 24 (14a) Operating deficit. – The shortage between revenues plus available reserves
 25 and operating expenditures, including capital expenditures, necessary to
 26 maintain operations in a distressed unit.

27 ...
 28 (22a) Viable Utility Reserve. – The Viable Utility Reserve established in
 29 G.S. 159G-22 as an account in the Water Infrastructure Fund.

30"
 31 **SECTION 1.(b)** G.S. 159G-22 is amended by adding two new subsections to read:
 32 "(h) Viable Utility Reserve. – The Viable Utility Reserve is established as an account
 33 within the Water Infrastructure Fund. The account is established to receive appropriated State
 34 funds to be used for grants to local government units for those purposes authorized under this
 35 Article. Revenue credited to the Viable Utility Reserve is neither received from the federal
 36 government nor provided as a match for federal funds.

37 (i) Viable Utility Accounts. – The Department is directed to establish accounts within
 38 the Viable Utility Reserve to administer grants for public water systems or wastewater systems
 39 owned by local government units."

40 **SECTION 1.(c)** G.S. 159G-30 reads as rewritten:
 41 "**§ 159G-30. Department's responsibility.**

42 The Department, through the ~~Division of Water Infrastructure,~~ Division, administers loans
 43 the following:

- 44 (1) Loans and grants made from the CWSRF, the DWSRF, the Wastewater
 45 Reserve, and the Drinking Water Reserve and shall administer the Reserve.
- 46 (2) The award of funds by the ~~State Water Infrastructure~~ Authority from the
 47 Community Development Block Grant program to local government units for
 48 infrastructure projects.
- 49 (3) Grants made from the Viable Utility Reserve."

50 **SECTION 1.(d)** G.S. 159G-31 is amended by adding two new subsections to read:

1 "(d) A local government unit is eligible to apply for a grant from the Viable Utility
2 Reserve.

3 (e) The Local Government Commission may submit an application on behalf of a
4 distressed unit for an emergency grant from the Viable Utility Reserve to cover operating deficits
5 of that local government unit's public water system or wastewater system, and any such
6 application shall be deemed approved by the Local Government Commission upon submission."

7 **SECTION 1.(e)** G.S. 159G-32 is amended by adding a new subsection to read:

8 "(d) Viable Utility Reserve. – The Department is authorized to make grants from the
9 Viable Utility Reserve to do any of the following:

10 (1) Provide physical interconnection and extension of public water or wastewater
11 infrastructure to provide regional service.

12 (2) Rehabilitate existing public water or wastewater infrastructure.

13 (3) Decentralize an existing public water system or wastewater system into
14 smaller viable parts.

15 (4) Fund a study of any one or more of the following:

16 a. Rates.

17 b. Asset inventory and assessment.

18 c. Merger and regionalization options.

19 (5) Fund other options deemed feasible which result in local government units
20 generating sufficient revenues to adequately fund management and
21 operations, personnel, appropriate levels of maintenance, and reinvestment
22 that facilitate the provision of reliable water or wastewater services.

23 (6) Provide emergency grants for operating deficits in accordance with
24 G.S. 159G-34.5(a)(4)."

25 **SECTION 1.(f)** Article 2 of Chapter 159G of the General Statutes is amended by
26 adding a new section to read:

27 **"§ 159G-34.5. Grant types available from Viable Utility Reserve.**

28 (a) The Department is authorized to make the following types of grants from the Viable
29 Utility Reserve:

30 (1) Asset assessment and rate study grant. – An asset inventory and assessment
31 grant is available to inventory the existing public water or wastewater system,
32 or both, document the condition of the inventoried infrastructure, and conduct
33 a rate study to determine a rate structure sufficient to prevent the local
34 government unit from becoming a distressed unit.

35 (2) Merger/regionalization feasibility grant. – A merger/regionalization grant is
36 available to determine the feasibility of consolidating the management of
37 multiple water or wastewater systems into a single operation or to provide
38 regional treatment or water supply and the best way of carrying out the
39 consolidation or regionalization. The Department shall not make a grant under
40 this subdivision for a merger or regionalization proposal that would result in
41 a new surface water transfer regulated under G.S. 143-215.22L.

42 (3) Project grant. – A project grant is available for a portion of the costs of a public
43 water system or wastewater system project as defined in G.S. 159G-32(d).

44 (4) Emergency grant for operating deficit. – An emergency grant for operating
45 deficits is available for distressed units if the Local Government Commission
46 has exercised its powers under G.S. 159-181 to assume full or partial control
47 over the affairs of the public water or wastewater system or of the local
48 government unit or public authority that owns or operates the public water or
49 wastewater system.

50 (b) A grant awarded from the Viable Utility Reserve may be awarded to a regional
51 council of government created under Part 2 of Article 20 of Chapter 160A of the General Statutes

1 or to a regional planning commission created under Article 19 of Chapter 153A of the General
2 Statutes, if the Department and the Local Government Commission determine it is in the best
3 interest of the local government unit.

4 (c) Each type of grant must be administered through a separate account within the Viable
5 Utility Reserve."

6 **SECTION 1.(g)** G.S. 159G-35 reads as rewritten:

7 "**§ 159G-35. Criteria for loans and grants.**

8 (a) CWSRF and DWSRF. – Federal law determines the criteria for awarding a loan or
9 grant from the CWSRF or the DWSRF. An award of a loan or grant from one of these accounts
10 must meet the criteria set under federal law. The Department is directed to establish through
11 negotiation with the United States Environmental Protection Agency the criteria for evaluating
12 applications for loans and grants from the CWSRF and the DWSRF and the priority assigned to
13 the criteria. The Department must incorporate the negotiated criteria and priorities in the
14 Capitalization Grant Operating Agreement between the Department and the United States
15 Environmental Protection Agency. The criteria and priorities incorporated in the Agreement
16 apply to a loan or grant from the CWSRF or the DWSRF. The priority considerations in
17 G.S. 159G-23 do not apply to a loan or grant from the CWSRF or the DWSRF.

18 (b) Certain Reserves. – The priority considerations in G.S. 159G-23 apply to a loan or
19 grant from the Wastewater Reserve or the Drinking Water Reserve. The Department may
20 establish by rule other criteria that apply to a loan or grant from the Wastewater Reserve or the
21 Drinking Water Reserve.

22 (c) Viable Utility Reserve. – The Local Government Commission and the Authority shall
23 jointly develop evaluation criteria for grants from the Viable Utility Reserve. These evaluation
24 criteria shall be used to review applications and award grants as provided in G.S. 159G-39."

25 **SECTION 1.(h)** G.S. 159G-36 reads as rewritten:

26 "**§ 159G-36. Limits on loans and grants.**

27 (a) CWSRF and DWSRF. – Federal law governs loans and grants from the CWSRF and
28 the DWSRF. An award of a loan or grant from one of these accounts must be consistent with
29 federal law.

30 (b) Certain Reserve Cost Limit. – The amount of a loan or grant from the Wastewater
31 Reserve or the Drinking Water Reserve may not exceed the construction costs of a project. A
32 loan or grant from one of these Reserves is available only to the extent that other funding sources
33 are not reasonably available to the applicant.

34 (b1) Viable Utility Reserve Cost Limit. – The amount of a grant from the Viable Utility
35 Reserve shall not exceed the construction costs of a project. A grant from this Reserve is available
36 only to the extent that other funding sources are not reasonably available to the applicant.

37 (c) Certain Reserve Recipient Limit. – The following limits apply to the loan or grant
38 types made from the Wastewater Reserve or the Drinking Water Reserve to the same local
39 government unit or nonprofit water corporation:

- 40 (1) The amount of loans awarded for a fiscal year may not exceed three million
41 dollars (\$3,000,000).
- 42 (2) The amount of loans awarded for three consecutive fiscal years for targeted
43 interest rate projects may not exceed three million dollars (\$3,000,000).
- 44 (3) The amount of project grants awarded for three consecutive fiscal years may
45 not exceed three million dollars (\$3,000,000).
- 46 (4) The amount of merger/regionalization feasibility grants awarded for three
47 consecutive fiscal years may not exceed fifty thousand dollars (\$50,000).
- 48 (5) The amount of asset inventory and assessment grants awarded for three
49 consecutive fiscal years may not exceed one hundred fifty thousand dollars
50 (\$150,000).

1 (d) Viable Utility Reserve Recipient Limit. – Grants under the Viable Utility Reserve are
2 limited as follows:

3 (1) Grants for the purposes set forth in subdivisions (1) through (5) of
4 G.S. 159-32(d) shall not exceed fifteen million dollars (\$15,000,000) to any
5 single local government unit. Where two or more local government units are
6 merging into a single utility, the total grant awarded shall not exceed thirty
7 million dollars (\$30,000,000).

8 (2) Grants for the purpose set forth in G.S. 159-32(d)(6) to any single local
9 government unit shall not (i) exceed seven hundred fifty thousand dollars
10 (\$750,000) in any fiscal year and (ii) be awarded for more than three
11 consecutive fiscal years."

12 **SECTION 1.(i)** G.S. 159G-37 reads as rewritten:

13 **"§ 159G-37. Application to CWSRF, Wastewater Reserve, DWSRF, ~~and Drinking Water~~**
14 **Reserve, Reserve, and Viable Utility Reserve.**

15 (a) Application. – An application for a loan or grant from the CWSRF, the Wastewater
16 Reserve, the DWSRF, or the Drinking Water ~~Reserve~~ Reserve, or a grant from the Viable Utility
17 Reserve, must be filed with the ~~Division of Water Infrastructure of the Department~~ Division. An
18 application must be submitted on a form prescribed by the Division and must contain the
19 information required by the Division. An applicant must submit to the Division any additional
20 information requested by the Division to enable the Division to make a determination on the
21 application. An application that does not contain information required on the application or
22 requested by the Division is incomplete and is not eligible for consideration. An applicant may
23 submit an application in as many categories as it is eligible for consideration under this Article.

24 (b) Certification. – ~~The Division of Water Infrastructure~~ shall require all local
25 governments applying for loans or grants for water or wastewater purposes to certify that no
26 funds received from water or wastewater utility operations have been transferred to the local
27 government's general fund for the purpose of supplementing the resources of the general fund.
28 The prohibition in this section shall not be interpreted to include payments made to the local
29 government to reimburse the general fund for expenses paid from that fund that are reasonably
30 allocable to the regular and ongoing operations of the utility, including, but not limited to, rent
31 and shared facility costs, engineering and design work, plan review, and shared personnel costs."

32 **SECTION 1.(j)** G.S. 159G-39 is amended by adding a new subsection to read:

33 **"(e) Viable Utility Reserve Terms.** – The Department shall not award a grant from the
34 Viable Utility Reserve Fund unless the Local Government Commission approves the award of
35 the grant and the terms of the grant. Any emergency grant application submitted under
36 G.S. 159G-31(e) shall be deemed approved by the Local Government Commission upon
37 submission. The Department and the Local Government Commission may, in their discretion,
38 impose specific performance measures or conditions on any grant awarded from the Viable
39 Utility Reserve, including any grant submitted under G.S. 159G-31(e)."

40 **SECTION 1.(k)** Article 2 of Chapter 159G of the General Statutes is amended by
41 adding a new section to read:

42 **"§ 159G-45. Assessment of local government units; assistance.**

43 (a) The Authority and the Local Government Commission shall develop criteria to
44 determine how local government units should be assessed and reviewed in accordance with this
45 section, and these criteria shall address at least all of the following:

46 (1) Whether the public water or wastewater system serves less than 10,000
47 customers.

48 (2) Whether the public water or wastewater system has an established,
49 operational, and adequately funded program for its repair, maintenance, and
50 management.

- 1 (3) Whether the annual debt service is disproportionate to the public water or
 2 wastewater system's annual revenue.
- 3 (4) Whether the local government unit has appropriated funds from its utility or
 4 public service enterprise fund in accordance with G.S. 159-13(b)(14) in two
 5 or more of the preceding five fiscal years without maintaining a reserve fund
 6 sufficient to provide for operating expenses, capital outlay, and debt service.
- 7 (5) Whether the local government unit has appropriated funds to supplement the
 8 operating expenses, capital outlay, or debt service on outstanding utility or
 9 enterprise bonds or notes in excess of the user fees collected in two or more
 10 of the preceding five fiscal years.

11 (b) Utilizing the assessment and review process, the Authority and Local Government
 12 Commission shall identify distressed units. Each distressed unit identified under this subsection
 13 shall do all of the following:

- 14 (1) Conduct an asset assessment and rate study, as directed and approved by the
 15 Authority and the Local Government Commission.
- 16 (2) Participate in a training and educational program approved by the Authority
 17 and the Local Government Commission for that distressed unit. Attendance
 18 shall be mandatory for any governing board members and staff whose
 19 participation is required by the Authority and Local Government Commission.
 20 The scope of training and education, and its method of delivery, shall be at the
 21 discretion of the Authority and Local Government Commission.
- 22 (3) Develop an action plan, taking into consideration all of the following:
- 23 a. A short-term and a long-term plan for infrastructure repair,
 24 maintenance, and management.
- 25 b. Continuing education of the governing board and system operating
 26 staff.
- 27 c. Long-term financial management to ensure the public water system or
 28 wastewater system will generate sufficient revenue to adequately fund
 29 management and operations, personnel, appropriate levels of
 30 maintenance, and reinvestment that facilitate the provision of reliable
 31 water or wastewater services.
- 32 d. Any other matters identified by the Authority or the Local Government
 33 Commission.

34 (c) Once an identified distressed unit has completed all of the requirements of subsection
 35 (b) of this section, that unit shall no longer be identified as a distressed unit for the remainder of
 36 that assessment and review cycle.

37 (d) The Authority and the Local Government Commission shall establish the frequency
 38 of the cycle for assessment and review of local government units under this section, which shall
 39 be no less than every two years."

40 **SECTION 2.** Chapter 162A of the General Statutes is amended by adding a new
 41 Article to read:

42 "Article 10.

43 "Dissolution and Merger of Units.

44 "§ 162A-850. "Unit" defined.

45 For purposes of this Article, the term "unit" means any of the following entities created
 46 pursuant to this Chapter:

- 47 (1) A water and sewer authority created pursuant to Article 1.
- 48 (2) A metropolitan water district created pursuant to Article 4.
- 49 (3) A metropolitan sewerage district created pursuant to Article 5.
- 50 (4) A metropolitan water and sewerage district created pursuant to Article 5A.
- 51 (5) A county water and sewer district created pursuant to Article 6.

"§ 162A-855. Information needed to merge or dissolve.

(a) Prior to any action by the Environmental Management Commission under this Article, for any unit to merge or dissolve, all of the following information must be supplied to the Environmental Management Commission:

- (1) The name of the unit or units to be merged or dissolved.
- (2) The names of the district board members of the unit or units to be merged or dissolved.
- (3) The proposed date of the merger or dissolution.
- (4) A map or description of the jurisdiction of the unit or units to be merged or dissolved.
- (5) The name of the entity with whom the unit or units will be merged, if applicable.
- (6) The names of the governing board members or district board members of the entity with which the unit is proposed to be merged, if applicable.
- (7) A map or description of the jurisdiction of the entity with which the unit is proposed to be merged.
- (8) Resolutions adopted by each district board or governing board requesting the merger or dissolution.
- (9) A request from each chair of a district board requesting a merger or dissolution that a representative of the Environmental Management Commission hold a public hearing in that district to discuss the proposed merger or dissolution and to receive public comment. The date, time, and place of the public hearing shall be mutually agreed to by the chair of the Environmental Management Commission and the chair of each requesting district board.
- (10) A copy of the most recent audit performed in accordance with G.S. 159-34 for the unit to be merged or dissolved.
- (11) A copy of any permits issued by the Department of Environmental Quality to the unit or units to be merged or dissolved.
- (12) A copy of any grant awarded under Article 2 of this Chapter involving the unit or units to be merged or dissolved and any conditions thereof, if applicable.
- (13) Any other information deemed necessary by the Department of Environmental Quality, the Local Government Commission, or the Environmental Management Commission.

(b) Upon receipt of a request to dissolve or merge, the Environmental Management Commission shall provide a copy of all information submitted in accordance with this section to the Department of Environmental Quality and the Local Government Commission.

(c) Upon confirmation of the time and place of the public hearing, each district board of an affected unit and any other governing board affected shall do all of the following:

- (1) Cause notice of the public hearing to be posted, at least 30 days prior to the hearing, at the courthouse in any county within which the affected unit lies.
- (2) Publish the notice at least once a week for four successive weeks in a newspaper having general circulation in the affected unit, the first publication to be at least 30 days prior to the public hearing.
- (3) Publish notice in any other manner required by the Environmental Management Commission.

"§ 162A-860. Merger of units.

(a) Any unit may merge with any other unit, any county, any city, any consolidated city-county, any sanitary district created pursuant to Part 2 of Article 2 of Chapter 130A of the General Statutes, any joint agency created pursuant to Part 1 or Part 5 of Article 20 of Chapter 160A of the General Statutes, or any joint agency that was created by agreement between two cities and towns to operate an airport pursuant to G.S. 63-56 and that provided drinking water

1 and wastewater services off the airport premises before January 1, 1995, if the merger is a
2 condition of receiving a grant from the Viable Utility Reserve as provided in Article 2 of Chapter
3 159G of the General Statutes. The Environmental Management Commission shall adopt a
4 resolution transferring the assets, liabilities, and other obligations to the entity with which the
5 unit is being merged and dissolving the unit as provided for in this Article.

6 (b) Any unit may merge with any other unit, any county, any city, any consolidated
7 city-county, any sanitary district created pursuant to Part 2 of Article 2 of Chapter 130A of the
8 General Statutes, any joint agency created pursuant to Part 1 or Part 5 of Article 20 of Chapter
9 160A of the General Statutes, or any joint agency that was created by agreement between two
10 cities and towns to operate an airport pursuant to G.S. 63-56 and that provided drinking water
11 and wastewater services off the airport premises before January 1, 1995, on approval by the
12 Environmental Management Commission, upon consultation with the Department of
13 Environmental Quality and the Local Government Commission. The Environmental
14 Management Commission may adopt a resolution transferring the assets, liabilities, and other
15 obligations to the entity with which the unit is being merged and dissolving the unit as provided
16 for in this Article, if the Environmental Management Commission deems the merger in the best
17 interest of the people of the State.

18 (c) The Environmental Management Commission shall adopt a resolution dissolving a
19 unit and transferring the assets, liabilities, and other obligations of the unit to another unit when
20 the procedures set forth in G.S. 162A-855 have been completed and all of the following apply:

21 (1) Both units are created pursuant to Article 5 of this Chapter.

22 (2) Both units are located in the same county.

23 (3) The jurisdiction of the units is contiguous.

24 (4) The unit to be merged and dissolved does not directly provide sewerage
25 services to any customers.

26 (5) The unit to be merged and dissolved leases its assets to the unit with which it
27 is proposed to be merged.

28 (6) The unit to be merged and dissolved has no outstanding debts.

29 **"§ 162A-865. Dissolution of units.**

30 (a) Any unit may be dissolved if the dissolution is a condition of a grant from the Viable
31 Utility Reserve as provided in Article 2 of Chapter 159G of the General Statutes. The
32 Environmental Management Commission shall adopt a resolution transferring the assets,
33 liabilities, and other obligations as provided for in the grant conditions imposed under Article 2
34 of Chapter 159G of the General Statutes.

35 (b) Any unit may be dissolved in order to merge that unit with any other unit, any county,
36 any city, any consolidated city-county, any sanitary district created pursuant to Part 2 of Article
37 2 of Chapter 130A of the General Statutes, any joint agency created pursuant to Part 1 or Part 5
38 of Article 20 of Chapter 160A of the General Statutes, or any joint agency that was created by
39 agreement between two cities and towns to operate an airport pursuant to G.S. 63-56 and that
40 provided drinking water and wastewater services off the airport premises before January 1, 1995,
41 and establish a new entity created under the General Statutes, on approval by the Environmental
42 Management Commission, upon consultation with the Department of Environmental Quality and
43 the Local Government Commission. The Environmental Management Commission may adopt a
44 resolution transferring the assets, liabilities, and other obligations to the new entity and dissolving
45 the unit as provided for in this Article, if the Environmental Management Commission deems the
46 merger in the best interest of the people of the State.

47 **"§ 162A-870. Effective date of merger or dissolution.**

48 Upon the adoption of a resolution of merger or dissolution by the Environmental
49 Management Commission as provided in this Article, the effective date for merger and
50 dissolution shall be fixed as of June 30 following the adoption of the resolution or the second
51 June 30 following the adoption of the resolution.

1 **"§ 162A-875. Effect of merger or dissolution.**

2 (a) Upon adoption of the resolution of merger or dissolution by the Environmental
3 Management Commission, all of the following shall apply on the effective date set forth in the
4 resolution:

- 5 (1) All property, real, personal, and mixed, including accounts receivable,
6 belonging to the dissolving unit shall be transferred, disposed of, or otherwise
7 accounted for as provided in the resolution of merger or dissolution.
- 8 (2) All judgments, liens, rights of liens, and causes of action of any nature in favor
9 of the dissolving unit shall vest in and remain and inure to the benefit of the
10 merged district.
- 11 (3) All taxes, assessments, sewer charges, and any other debts, charges, or fees
12 owing to the dissolving unit shall be owed to and collected as provided in the
13 resolution of merger or dissolution.
- 14 (4) All actions, suits, and proceedings pending against, or having been instituted
15 by, the dissolving unit shall not be abated by merger, but all such actions,
16 suits, and proceedings shall be continued and completed in the same manner
17 as if merger had not occurred, and the merged entity shall be a party to all
18 such actions, suits, and proceedings in the place and stead of the dissolving
19 unit and shall pay or cause to be paid any judgments rendered against the
20 dissolving unit in any such actions, suits, or proceedings. No new process is
21 required to be served in any such action, suit, or proceeding.
- 22 (5) All obligations of the dissolving unit, including outstanding indebtedness,
23 shall be assumed as provided in the resolution of merger or dissolution, and
24 all such obligations and outstanding indebtedness shall constitute obligations
25 and indebtedness as provided in the resolution of merger or dissolution.
- 26 (6) All ordinances, rules, regulations, and policies of the dissolving unit shall
27 continue in full force and effect until repealed or amended by the governing
28 body of the merged entity.
- 29 (7) The dissolving unit shall be abolished and shall no longer be constituted a
30 public body or a body politic and corporate, except for purposes of carrying
31 into effect the provisions and intent of this section.
- 32 (8) Governance of the district shall be as specified in the resolution of merger or
33 dissolution, which may be amended by the Environmental Management
34 Commission, as needed.

35 (b) All governing boards and district boards are authorized to take the actions and execute
36 the documents necessary to effectuate the provisions and intent of this section."

37 **SECTION 3.** Article 20 of Chapter 160A of the General Statutes is amended by
38 adding a new Part to read:

39 "Part 5. Water and Wastewater Systems.

40 **"§ 160A-481.1. Definitions.**

41 The words defined in this section shall have the meanings indicated when used in this Part:

- 42 (1) Local government unit. – Defined in G.S. 159G-20 and G.S. 160A-460.
43 (2) Undertaking. – Defined in G.S. 160A-460.

44 **"§ 160A-481.2. Interlocal cooperation authorized.**

45 Interlocal cooperation, as provided in Part 1 of this Article, is authorized between any local
46 government units in this State for any purpose. When two or more local government units agree
47 to contract for one or more undertakings under this Part, the provisions of Part 1 of this Article
48 apply."

49 **SECTION 4.** The Department of Environmental Quality shall study the statutes and
50 rules governing subbasin transfers and make recommendations as to whether the statutes and
51 rules should be amended. The study shall specifically examine whether transfers of water

1 between subbasins within the same major river basin should continue to be required to comply
2 with all of the same requirements under G.S. 143-215.22L as transfers of water between major
3 river basins. In conducting this study, the Department of Environmental Quality shall consider
4 whether the costs of complying with specific requirements, including financial costs and time,
5 are justified by the benefits of the requirements, including the production of useful information
6 and public notice and involvement. No later than January 15, 2021, the Department of
7 Environmental Quality shall report its findings and recommendations to the Environmental
8 Review Commission.

9 **SECTION 5.** The Department of State Treasurer shall study and make
10 recommendations as to the feasibility of authorizing historical charters for units of local
11 government that have become, or are on the brink of becoming, defunct. The study shall
12 specifically examine whether these historical charters are needed, the impact of these charters on
13 the bond rating of the State and its political subdivisions, and the consequences of these historical
14 charters. No later than January 15, 2021, the Department of State Treasurer shall report its
15 findings and recommendations to the General Assembly.

16 **SECTION 6.(a)** Subsections (d), (e), (f), (g), and (h) of Section 11 of Session Law
17 2019-241 are repealed.

18 **SECTION 6.(b)** If Senate Bill 553, 2019 Regular Session, becomes law, then Section
19 14 of that act is repealed.

20 **SECTION 6.(c)** Subsection (a) of this section becomes effective June 30, 2020.

21 **PART II. FUNDING**

22 **SECTION 7.(a)** No later than August 15, 2020, the Department of Commerce shall
23 transfer the sum of nine million dollars (\$9,000,000) in nonrecurring funds for the 2020-2021
24 fiscal year from the One North Carolina Fund (Budget Code: 24609; Fund Code: 2560) to the
25 Water Infrastructure Fund administered by the Department of Environmental Quality's Division
26 of Water Infrastructure (Budget Code: 24327).

27 **SECTION 7.(b)** The funds transferred by this section are appropriated to the Viable
28 Utility Reserve established by G.S. 159G-22, as amended by this act, to be used for the purposes
29 set forth in G.S. 159G-32, as amended by this act.

30 **SECTION 8.** There is appropriated from the General Fund to the Board of Governors
31 of The University of North Carolina the sum of four million eight hundred thousand dollars
32 (\$4,800,000) in nonrecurring funds for the 2020-2021 school year to be allocated to the Southern
33 Regional Area Health Education Center (SR AHEC) to be used for residencies in the SR AHEC
34 service areas and for facility and structural improvements associated with current residency
35 programs.

38 **PART III. GENERAL PROVISIONS**

39 **STATE BUDGET ACT APPLIES**

40 **SECTION 9.** The provisions of the State Budget Act, Chapter 143C of the General
41 Statutes, are reenacted and shall remain in full force and effect and are incorporated in this act
42 by reference.

45 **ADDITIONAL LIMITATIONS AND DIRECTIONS**

46 **SECTION 10.** Except where expressly repealed or amended by this act, the
47 provisions of any other legislation enacted during the 2019 Regular Session of the General
48 Assembly expressly appropriating funds to an agency, a department, or an institution covered
49 under this act shall remain in effect.

SECTION 11. Except as otherwise specified, this act becomes effective July 1, 2020.
