Short Title: PED Report/Student Financial Assistance. (Public) Sponsors: Referred to: April 30, 2020 1 A BILL TO BE ENTITLED 2 AN ACT TO MAKE NECESSARY IMPROVEMENTS TO ENSURE STATE FUNDS FOR 3 POSTSECONDARY EDUCATIONAL FINANCIAL AID PROGRAMS ARE FULLY 4 EXPENDED AND TO GAUGE THE EFFECTIVENESS OF THOSE PROGRAMS. 5 The General Assembly of North Carolina enacts: 6 SECTION 1.(a) G.S. 116-209.45(j) reads as rewritten: 7 Report to the General Assembly. - The Authority shall report no later than December "(j) 8 1, 2013, and annually thereafter to the Joint Legislative Education Oversight Committee regarding the Fund and loans awarded from the Fund.Fund, including the total number of loan 9 recipients by year who either (i) have met employment service requirements for loan forgiveness 10 11 or (ii) elect cash loan repayment, including when years of employment are credited toward loan forgiveness prior to beginning cash repayment. The individual records used to generate this report 12 13 shall be retained for a period of five years." 14 **SECTION 1.(b)** Notwithstanding G.S. 116-209.45(j), as amended by this section, 15 the State Education Assistance Authority (Authority) shall include initial information on loan 16 recipients of the Forgivable Education Loans for Service Program in its annual report no later than December 1, 2022. This initial information on the loan recipients shall also include the 17 18 recipients' field of work. 19 **SECTION 1.(c)** The Authority shall develop and maintain a record-keeping system 20 to track the repayment methods utilized by the recipients of State-funded educational loans that are eligible for forgiveness based on meeting individual program employment service 21 requirements. The record-keeping system shall facilitate meeting data reporting requirements on 22 23 State-funded educational loan programs, including for (i) the North Carolina Teaching Fellows 24 Program under G.S. 116-209.62(j)(2) and (ii) the Forgivable Education Loans for Service Program under G.S. 116-209.45(j), and inform whether such programs are meeting the 25 employment needs of the State. The Authority shall report on its progress in implementing the 26 27 record-keeping system required by this section to the Joint Legislative Education Oversight Committee and the Joint Legislative Program Evaluation Oversight Committee by January 1, 28 29 2021. 30 SECTION 2.(a) G.S. 116-209.14 reads as rewritten: 31 "§ 116-209.14. Annual-Strategic plan; reports. 32 Strategic Plan. – The Authority shall biennially develop and maintain a strategic plan (a) 33 that sets forth the performance goals of the Authority in administering State-funded financial 34 assistance for postsecondary programs in accordance with State law. The strategic plan shall 35 include comprehensive performance measures in order to track and evaluate the Authority's 36 effectiveness and progress toward meeting the performance goals established in the strategic

1	plan. The Authority shall make the most recent strategic plan publicly available on its Web site
2	each year.
3	(b) <u>Annual Reports. – The Authority shall, following the close of each fiscal year, publish</u>
4	an annual report of the implementation of its strategic plan and its activities for the preceding
5	year to the Governor and the General Assembly. Each report shall set forth a include at least the
6	following information:
7	(1) The strategic plan adopted by the Authority pursuant to subsection (a) of this
8	section.
9	(2) <u>A complete operating and financial statement covering the operations of the</u>
10	Authority during the year.
11	(3) Data metrics on the administration of State-funded financial assistance
12	programs and recipients of financial assistance, including the following:
13	<u>a.</u> <u>Information for each postsecondary institution enrolling students</u>
14	using State-funded financial assistance, including the amount of
15	financial assistance used by students for each program administered
16	by the Authority.
17	b. <u>Demographic information on students who receive State-funded</u>
18	<u>financial assistance, including socioeconomic profiles with income</u>
10 19	and dependency status for that fiscal year.
20	(c) <u>Oversight. – The operations of the Authority shall be subject to the oversight of the</u>
20 21	State Auditor pursuant to Article 5A of Chapter 147 of the General Statutes."
21	<b>SECTION 2.(b)</b> By January 1, 2021, the Authority shall report to the Joint
22	Legislative Education Oversight Committee and the Joint Legislative Program Evaluation
23 24	Oversight Committee on its progress in meeting the requirements set forth in subsection (a) of
25	this section.
25 26	<b>SECTION 2.(c)</b> Subsection (a) of this section becomes effective July 1, 2021.

28	"§ 116-25.1. Semester limitation on eligibility for The University of North Carolina

30	(a) <u>Grant Limitation. – Except as otherwise provided by this section, a student shall not</u>
31	receive a grant from The University of North Carolina Need-Based Financial Aid Program for
32	more than 10 full-time academic semesters, or its equivalent if enrolled part-time, unless the
33	student is enrolled in a program officially designated by the Board of Governors as a five-year
34	degree program. If a student is enrolled in such a five-year degree program, then the student shall
35	not receive a need-based grant from The University of North Carolina Need-Based Financial Aid
36	Program for more than 12 full-time academic semesters or its equivalent if enrolled part-time.
37	(b) <u>Waiver on Grant Limitation.</u> Upon application by a student, the constituent
38	institution may grant a waiver to the student <u>on the limitation set forth in subsection (a) of this</u>
39	section who may then receive a grant for the equivalent of one additional full-time academic
40	semester if the student demonstrates that any of the following have substantially disrupted or
40 41	interrupted the student's pursuit of a degree: (i) a military service obligation, (ii) serious medical
42	debilitation, (iii) a short-term or long-term disability, or (iv) other extraordinary hardship. The

43 44	Board of Governors shall establish policies and procedures to implement the waiver provided by this subsection.

	(c) Administrative Costs. – The State Education Assistance Authority may use up to one and one half percent (1.5%) of the funds appropriated for The University of North Carolina
46 47	and one-half percent (1.5%) of the funds appropriated for The University of North Carolina
47 48	<u>Need-Based Financial Aid Program each fiscal year for administrative costs.</u> "
	<b>SECTION 3.(b)</b> This section becomes effective July 1, 2020.
49 50	<b>SECTION 4.</b> The Office of State Budget and Management (OSBM) shall develop
50 51	recommendations on increasing transparency in administrative cost reporting for the Need-Based
51	Scholarships for Students Attending Private Institutions of Higher Education Program

established under Article 34 of Chapter 116 of the General Statutes. The recommendations shall
include a method for reporting program funding received by the Authority in its financial
statements. OSBM shall report on the recommendations, including a time line for implementation
of proposed changes and any required legislative modifications, to the Joint Legislative
Education Oversight Committee and the Joint Legislative Program Evaluation Oversight
Committee by October 1, 2020.
SECTION 5. Except as otherwise provided, this act is effective when it becomes
