8 **SECTION 2.6.** Section 4.12(b) of S.L. 2020-3 reads as rewritten:

9 **"SECTION 4.12.(b)** This section is effective when it becomes law and expires ~~August 1,~~  
10 ~~2020.~~March 1, 2021."

12 **EXTEND SUNSET ON REMOTE NOTARY AND VIDEO WITNESSING**  
13 **AUTHORIZATION**

14 **SECTION 2.7.(a)** G.S. 10B-10(b1), as enacted by S.L. 2020-3, reads as rewritten:

15 "(b1) Notwithstanding subsection (b) of this section, if the Secretary grants a commission  
16 after March 9, 2020, and before March 1, 2021, the appointee shall have 90 days to appear before  
17 the register of deeds to take the general oath of office. A register of deeds may administer the  
18 required oath to such appointee using video conference technology provided the appointee is  
19 personally known to the register of deeds or the appointee provides satisfactory evidence of the  
20 appointee's identity to the register of deeds. As used in this subsection, video conference  
21 technology and satisfactory evidence are as defined in G.S. 10B-25."

22 **SECTION 2.7.(b)** G.S. 10B-25(n), as enacted by S.L. 2020-3, reads as rewritten:

23 "(n) This section shall expire at 12:01 A.M. on March 1, 2021; provided, however, all  
24 notarial acts made in accordance with this section and while this section is in effect shall remain  
25 effective and shall not need to be reaffirmed."

26 **SECTION 2.7.(c)** G.S. 10B-200(b), as enacted by S.L. 2020-3, reads as rewritten:

27 "(b) This Article expires March 1, 2021.""
