A BILL TO BE ENTITLED

AN ACT AMENDING THE CAMPAIGN FINANCE LAWS TO RAISE THE LIMIT ON  
MERCHANDISE SALES FOR POLITICAL PARTIES AND TO PROVIDE FOR  
AT-LARGE ELECTION OF DISTRICT COURT JUDGES IN MECKLENBURG  
COUNTY AND TO EXTEND THE SUNSET FOR MASKS AND HOODS FOR THE  
PROTECTION OF HEALTH.

The General Assembly of North Carolina enacts:

**SECTION 1.(a)** G.S. 163-278.8A(b)(2) reads as rewritten:

"(b) Exempt Purchase Price. – A purchase price for goods or services sold by a political party executive committee or affiliated party committee qualifies for the exemption provided in subsection (a) of this section as long as the sale of the goods or services adheres to a plan that the treasurer has submitted to and that has been approved in writing by the Executive Director of the State Board of Elections. The Executive Director shall approve the treasurer's plan upon and only upon finding that all the following requirements are satisfied:

(2) That the total amount to be raised from sales under all plans by the committee does not exceed ~~ten~~ twenty thousand dollars ~~(\$10,000)~~ (\$20,000) per election cycle.

...."

**SECTION 1.(b)** This section is effective when it becomes law and applies to election cycles occurring on or after that date.

**SECTION 2.(a)** G.S. 7A-133 reads as rewritten:

"§ 7A-133. **Numbers of judges by districts; numbers of magistrates and additional seats of court, by counties.**

15 **SECTION 2.(b)** Section 2(b) of S.L. 2018-14 reads as rewritten:

16 "**SECTION 2.(b)** In order to implement the district court districts as enacted by this section,

47 **SECTION 2.(c)** This section becomes effective January 1, 2021, and applies to  
 48 elections conducted on or after that date. All elections in 2020 shall be conducted in accordance  
 49 with the Consent Order as it was filed on November 27, 2019, in Alexander v. North Carolina  
 50 State Board of Elections, 19 CVS 011321, Wake County.

51 **SECTION 2.5.** Section 4.3(b) of S.L. 2020-3 reads as rewritten:

1        "**SECTION 4.3.(b)** This section is effective when it becomes law and expires ~~August 1,~~  
2        ~~2020.~~February 15, 2021."  
3                **SECTION 3.** Except as otherwise provided, this act is effective when it becomes  
4        law.
