3 BIENNIUM, CONSISTENT WITH CERTAIN POLICY DIRECTIVES IN RATIFIED
4 HOUSE BILL 966 OF THE 2019 REGULAR SESSION; MODIFYING STAFFING IN THE
5 OFFICE OF RECOVERY AND RESILIENCY; AND CLARIFYING THAT PARTIES TO
6 AN INTERGOVERNMENTAL SUPPORT AGREEMENT WITH A MAJOR MILITARY
7 INSTALLATION THAT OPERATES A PSAP MAY USE 911 FUNDS FOR NEXT
8 GENERATION 911 SYSTEM COMPATIBILITY.

9 The General Assembly of North Carolina enacts:

11 **PART I. GENERAL PROVISIONS**

12
13 **EDUCATION LOTTERY FUND**

14 **SECTION 1.1.** G.S. 18C-164(b1) reads as rewritten:

15 "(b1) Net revenues credited to the Education Lottery Fund shall be appropriated in an
16 amount equal to the amount appropriated from the Education Lottery Fund in the Current
17 Operations and Capital Improvements Appropriations Act of 2017 Fund."

19 **PART II. PUBLIC INSTRUCTION**

20
21 **ELIMINATE REPORT TO SUPERINTENDENT ON THE ADOPTED SCHEDULE OF**
22 **FEEES**

23 **SECTION 2.1.(a)** G.S. 115C-47(6) reads as rewritten:

24 "(6) To Regulate Fees, Charges and Solicitations. – Local boards of education shall
25 adopt rules and regulations governing solicitations of, sales to, and
26 fund-raising activities conducted by, the students and faculty members in
27 schools under their jurisdiction, and no fees, charges, or costs shall be
28 collected from students and school personnel without approval of the board of
29 education as recorded in the minutes of said board; provided, this subdivision
30 shall not apply to such textbooks fees as are determined and established by the
31 State Board of Education. ~~All schedules of fees, charges and solicitations~~
32 ~~approved by local boards of education shall be reported to the Superintendent~~
33 ~~of Public Instruction.~~ The local board of education shall publish a schedule of

1 fees, charges, and solicitations approved by the local board on the local school
2 administrative unit's Web site by October 15 of each school year and, if the
3 schedule is subsequently revised, within 30 days following the revision."

4 **SECTION 2.1.(b)** This section applies beginning with the 2020-2021 school year.
5

6 **AUTHORIZE THE NC CTE EDUCATION FOUNDATION TO ADMINISTER**
7 **CERTAIN GRANTS**

8 **SECTION 2.2.(a)** G.S. 115C-64.15 reads as rewritten:

9 **"§ 115C-64.15. North Carolina Education and Workforce Innovation Commission.**

10 ...

11 (d) The Commission shall develop and administer the Education and Workforce
12 Innovation Program, as established under G.S. 115C-64.16, in collaboration with the North
13 Carolina Career and Technical Education Foundation, Inc., and make awards of grants under the
14 Program.

15 (d1) The Commission shall develop and administer, in coordination with the State Board
16 of Education and the Superintendent of Public Instruction, and in collaboration with the North
17 Carolina Career and Technical Education Foundation, Inc., the Career and Technical Education
18 Grade Expansion Program, as established under G.S. 115C-64.17, and shall make awards of
19 grants under the Program.

20 (d2) The North Carolina Career and Technical Education Foundation, Inc., shall serve as
21 a grant administrator by providing assistance and support to grantees for initiating, expanding,
22 improving, and promoting career and technical education initiatives.

23 (e) ~~The Commission~~ Commission, in consultation with the North Carolina Career and
24 Technical Education Foundation, Inc., shall publish a report on the Education and Workforce
25 Innovation Program and the Career and Technical Education Grade Expansion Program on or
26 before April 30 of each year. The report shall be submitted to the Joint Legislative Education
27 Oversight Committee, the State Board of Education, the State Board of Community Colleges,
28 and the Board of Governors of The University of North Carolina. The report shall include at least
29 all of the following information:

- 30 (1) An accounting of how funds and personnel resources were utilized for each
31 program and their impact on student achievement, retention, and
32 employability.
33 (2) Recommended statutory and policy changes.
34 (3) Recommendations for improvement of each program.
35 (4) For the Career and Technical Education Grade Expansion Program,
36 recommendations on increasing availability of grants after the first two years
37 of the program to include additional local school administrative units or
38 providing additional grants to prior recipients."

39 **SECTION 2.2.(b)** G.S. 115C-64.17(c) reads as rewritten:

40 "(c) Selection of Recipients. – For the 2017-2018 fiscal year, the Commission shall accept
41 applications for a grant until November 30, 2017. For subsequent fiscal years that funds are made
42 available for the Program, the Commission shall accept applications for a grant until August 1 of
43 each year. The Commission shall consult with the North Carolina Career and Technical
44 Education Foundation, Inc., to select recipients in a manner that considers diversity among the
45 pool of applicants, including geographic location, location of industries in the area in which a
46 local school administrative unit is located, and the size of the student population served by the
47 unit, in order to award funds to the extent possible to grant recipients that represent different
48 regions and characteristics of the State. The Commission shall recommend recipients of the
49 grants to the State Board of Education. The State Board, upon consultation with the
50 Superintendent of Public Instruction, shall approve the recipients of grant awards."

1 **SECTION 2.2.(c)** This section shall apply to the administration of grant programs
2 on or after the date this act becomes law.

4 **BROADEN CERTAIN CHARTER SCHOOL ENROLLMENT PRIORITIES**

5 **SECTION 2.3.(a)** G.S. 115C-218.45(f) reads as rewritten:

6 "(f) The charter school may give enrollment priority to any of the following:

7 (1) Siblings of currently enrolled students who were admitted to the charter school
8 in a previous year. For the purposes of this section, the term "siblings"
9 includes any of the following who reside in the same household: half siblings,
10 stepsiblings, and children residing in a family foster home.

11 (1a) Siblings who apply to the charter school for admission beginning in the same
12 school year, such as when a sibling was not initially admitted due to grade
13 level capacity.

14 (2) Siblings of students who have completed the highest grade level offered by
15 that school and who were enrolled in at least four grade levels offered by the
16 charter school or, if less than four grades are offered, in the maximum number
17 of grades offered by the charter school.

18 (2a) A student who was enrolled in a preschool program operated by the charter
19 school in the prior year.

20 (3) Limited to no more than fifteen percent (15%) of the school's total enrollment,
21 unless granted a waiver by the State Board of Education, the following:

22 a. Children of the school's full-time employees, persons (i) employed full
23 time by the charter school or (ii) working full time in the daily
24 operation of the charter school, including children of persons
25 employed by an education management organization or charter
26 management organization for the charter school.

27 b. Children of the charter school's board of directors.

28 (4) A student who was enrolled in the charter school within the two previous
29 school years but left the school (i) to participate in an academic study abroad
30 program or a competitive admission residential program or (ii) because of the
31 vocational opportunities of the student's parent.

32 (5) A student who was enrolled in another charter school in the State in the
33 previous school year that does not offer the student's next grade level.

34 (6) A student who was enrolled in another charter school in the State in the
35 previous school year that does not offer the student's next grade level and both
36 of the charter schools have an enrollment articulation agreement to accept
37 students or are governed by the same board of directors.

38 (7) A student who was enrolled in another charter school in the State in the
39 previous school year."

40 **SECTION 2.3.(b)** This section is effective when it becomes law and applies
41 beginning with the 2020-2021 school year.

43 **EXPAND SCHOOLS THAT LEAD PILOT PROGRAM**

44 **SECTION 2.4.** Section 7.25(a) of S.L. 2018-5 reads as rewritten:

45 **"SECTION 7.25.(a)** Program; Purpose. – Of the funds appropriated to the Department of
46 Public Instruction by this act for the Schools That Lead Pilot Program (Program), the Department
47 shall contract with Schools That Lead, Inc., to provide professional development to teachers and
48 principals in up to ~~60~~75 schools, beginning with the 2018-2019 school year and ending in the
49 2020-2021 school year. The selected schools shall be charter schools or schools under the
50 authority of a local school administrative unit. Professional development services shall be offered
51 to teachers and principals in grades K-12. The Superintendent of Public Instruction, in

1 consultation with Schools That Lead, Inc., shall determine which schools are eligible to
2 participate in the Program. At a minimum, the Program shall offer services to three cohorts of
3 schools, as follows:

- 4 (1) High schools working to increase on-time graduation.
- 5 (2) Middle schools working to prepare students to succeed in high school by
6 reducing the likelihood of retention in the ninth grade for multiple school
7 years.
- 8 (3) Elementary schools working to reduce the number of students with early
9 warning indicators of course failures, absences, and discipline."

10 11 **ARTS EDUCATION GRADUATION REQUIREMENT**

12 **SECTION 2.5.(a)** The State Board of Education shall modify the State graduation
13 requirements to include one required credit in arts education to be completed by each student at
14 any time in grades six through 12.

15 The State Board of Education shall implement the arts education graduation
16 requirement beginning with students entering the sixth grade in 2022. The State Board shall
17 include an exemption from the arts education graduation requirement for students transferring
18 into a North Carolina public school beginning in the ninth grade or later, if such requirement
19 would prevent a student from graduating with the graduation cohort to which the student was
20 assigned when transferring.

21 **SECTION 2.5.(b)** The State Board of Education shall do the following:

- 22 (1) Establish procedures and a time line for a phased-in implementation of the arts
23 education graduation requirement.
- 24 (2) Establish the minimum criteria to meet the arts education graduation
25 requirement.
- 26 (3) By December 15, 2022, report to the Joint Legislative Education Oversight
27 Committee on the following:
 - 28 a. The statewide implementation of the three interdependent components
29 of comprehensive arts education (arts education, arts integration, and
30 arts exposure).
 - 31 b. The graduation requirement set forth in subsection (a) of this section.

32 33 **ADVANCED TEACHING ROLES CHANGES**

34 **SECTION 2.6.(a)** Effective June 30, 2021, the following session laws are repealed:

- 35 (1) Section 8.7 of S.L. 2016-94.
- 36 (2) Subsection (a) of Section 7.11 of S.L. 2017-57.
- 37 (3) Subsections (a) and (b) of Section 7.15 of S.L. 2017-57.
- 38 (4) Section 7.9 of S.L. 2018-5.
- 39 (5) Section 2.6 of S.L. 2018-97.

40 **SECTION 2.6.(b)** Article 20 of Chapter 115C of the General Statutes is amended by
41 adding a new section to read:

42 **"§ 115C-311. Teacher compensation models and advanced teaching roles.**

43 (a) Purpose. – The State Board of Education shall establish a program (program) to
44 develop advanced teaching roles and organizational models that link teacher performance and
45 professional growth to salary increases for classroom teachers in selected local school
46 administrative units. For the purposes of this section, a classroom teacher is a teacher who works
47 in the classroom providing instruction at least seventy percent (70%) of the instructional day and
48 who is not instructional support personnel. The purpose of the program shall be to do the
49 following:

- 50 (1) Allow highly effective classroom teachers to teach an increased number of
51 students by assuming accountability for additional students, by becoming a

- 1 lead classroom teacher accountable for the student performance of all of the
2 students taught by teachers on that lead classroom teacher's team, or by
3 leading a larger effort in the school to implement new instructional models to
4 improve school-wide performance.
- 5 (2) Enable local school administrative units to provide salary supplements to
6 classroom teachers in advanced teaching roles. Selection of an advanced
7 teaching role classroom teacher and award of related salary supplements shall
8 be made on the basis of demonstrated effectiveness and additional
9 responsibilities.
- 10 (3) Enable local school administrative units to create innovative compensation
11 models that focus on classroom teacher professional growth that lead to
12 measurable improvements in student outcomes.
- 13 (4) Utilize local plans to establish organizational changes related to compensation
14 in order to sustain evidence-based teaching practices that have the capacity to
15 be replicated throughout the State.
- 16 (b) Request for Proposal. – By September 15, 2020, and annually thereafter, the State
17 Board of Education shall issue a Request for Proposal (RFP) for the program. Local boards of
18 education shall submit their proposals by October 15. The RFP shall require that proposals
19 include the following information at a minimum:
- 20 (1) Description of the program structure, including both of the following:
21 a. The process for teacher advancement based on performance,
22 professional growth, or the specific teacher roles assumed by the
23 teacher.
24 b. Plans for how the local school administrative unit will utilize and train
25 classroom teachers in advanced teaching roles. These plans shall draw
26 a direct correlation between the proposed use and training of
27 classroom teachers in advanced teaching roles and improved student
28 outcomes.
- 29 (2) Descriptions of the advanced teaching roles, including minimum
30 qualifications for the positions that shall include at least two of the following:
31 a. Advanced certifications, such as National Board for Professional
32 Teaching Standards Certification, or a master's degree in the area in
33 which the classroom teacher is licensed and teaching.
34 b. A rating of at least accomplished on each of the Teacher Evaluation
35 Standards 1-5 on the North Carolina Teacher Evaluation instrument.
36 c. Evidence that the teacher has an average Education Value-Added
37 Assessment System (EVAAS) student growth index score from the
38 three previous school years of 1.5 or greater and no individual EVAAS
39 student growth index score below zero.
40 d. Equivalent demonstrated mastery of teaching skills as required by the
41 new local compensation model.
- 42 (3) Job responsibilities that include at least one of the following:
43 a. Teaching an increased number of students and being accountable for
44 their performance as the teacher of record for those students.
45 b. Becoming a lead classroom teacher among a group of teachers and
46 participating in EVAAS according to a model developed by the
47 Department of Public Instruction. The model shall be published and
48 explained on the Department's Web site no later than August 1, 2020,
49 and, thereafter, within 30 days of any change made to the model.
50 c. Leading a school-wide effort to implement data-driven instructional
51 models that include blended learning environments, utilizing digital

- 1 learning and resources, and focusing on methods of improvement for
2 school-wide performance issues.
- 3 d. Providing in-house professional development or functioning as an
4 instructional content area coach or a coach in another professional
5 development area following the completion of certification training.
6 The training shall ensure that the professional development or
7 coaching the teacher provides is faithfully implemented in the
8 classroom.
- 9 (4) Description of how the local school administrative unit will inform all
10 employees and the public on the criteria and selection for the advanced
11 teaching roles, the continued eligibility requirements for the advanced
12 teaching roles, and how the individuals selected for the advanced teaching
13 roles will be evaluated.
- 14 (5) Description of how the local school administrative unit will inform all
15 employees and the public on the criteria for movement on the proposed new
16 local compensation model.
- 17 (6) The process for the voluntary relinquishment of an advanced teaching role,
18 including the associated additional duties. Voluntary relinquishment of the
19 advanced teaching role shall not be considered a demotion under Part 3 of
20 Article 22 of Chapter 115C of the General Statutes.
- 21 (7) Salary supplement information including the following:
- 22 a. The amount of the salary supplements that will be provided to those
23 selected for the advanced teaching roles. The supplements may be up
24 to thirty percent (30%) of the State teacher salary schedule.
- 25 b. A statement by the local school administrative unit that the salary
26 supplements will be paid as a supplement to the classroom teacher's
27 regular salary and not be included in the average salary calculation
28 used for budgeting State allotments.
- 29 c. A statement by the local school administrative unit that if a classroom
30 teacher in an advanced teaching role (i) fails to maintain the minimum
31 criteria established for the position, (ii) is not successfully performing
32 the additional duties associated with the advanced teaching role, or (iii)
33 voluntarily relinquishes the advanced teaching role, the teacher shall
34 only be paid the salary applicable to that individual on the State teacher
35 salary schedule and any other local supplements that would otherwise
36 apply to the classroom teacher's compensation.
- 37 d. Loss of an advanced teaching role shall not be considered a demotion
38 under Part 3 of Article 22 of Chapter 115C of the General Statutes.
- 39 e. The amount of the salary supplements at all levels of the proposed new
40 compensation model in relation to the State teacher salary schedule.
- 41 (8) The implementation plan, including the number of schools in the local school
42 administrative unit that will have advanced teaching roles and any new
43 proposed compensation model, the number of advanced teaching roles at each
44 of those schools, the number of students whose teacher of record will be a
45 teacher in an advanced teaching role, and the number of teachers overall who
46 would be eligible for the proposed new compensation model.
- 47 (9) Plans for long-term financial sustainability once any grant money that may be
48 awarded to the local school administrative unit is no longer available. This
49 plan shall include a description of how the unit intends to provide
50 supplemental compensation for teachers in an advanced teaching role without
51 grant money.

1 (10) A description of how the local school administrative unit could partner with
2 local educator preparation programs, institutions of higher education, or
3 community colleges to improve teacher effectiveness and student outcomes.

4 (c) Selection by State Board of Education. – By December 15, 2020, and annually
5 thereafter, the State Board of Education shall review proposals and select local school
6 administrative units to participate in the program, beginning in the subsequent school year, in
7 accordance with the following criteria:

8 (1) Selected local school administrative units must meet minimum criteria
9 established by the State Board of Education consistent with this section.

10 (2) The State Board shall prioritize the award of available State funds for the
11 following categories of local school administrative units:

12 a. Up to five units with an average daily membership from the previous
13 school year of 4,000 or fewer students.

14 b. Up to five units with an average daily membership from the previous
15 school year of between 4,001 and 20,000 students.

16 c. Up to five units with an average daily membership from the previous
17 school year of 20,001 or more students.

18 (3) The State Board shall approve the proposal of any local school administrative
19 unit that is submitted by October 15, 2020, if the following criteria are met:

20 a. The local school administrative unit is participating in an approved
21 advanced teaching roles program pursuant to Section 8.7 of S.L.
22 2016-94 in the 2020-2021 school year.

23 b. The application of a local school administrative unit is not inconsistent
24 with this section.

25 (d) Advanced Teaching Roles Designation. – Any local board of education that is
26 selected to participate in the program pursuant to subsection (c) of this section shall designate
27 participating schools within the unit as "Advanced Teaching Roles" schools. Advanced Teaching
28 Roles schools shall receive class size flexibility subject to subsection (i) of this section and budget
29 flexibility subject to subsection (j) of this section.

30 (e) Material Revisions of Plans. – Material revisions of a plan submitted to the State
31 Board of Education by a local board of education with at least one Advanced Teaching Roles
32 school shall be made only upon the approval of the State Board of Education.

33 (f) Renewal and Termination. – The initial selected local school administrative units
34 shall implement their approved plans beginning with the 2021-2022 school year. Every five years
35 after a local school administrative unit begins implementing its plan, the State Board of Education
36 shall review the unit to ensure it is complying with its approved plan. After the review, the State
37 Board may, in its discretion, renew or terminate the plan of any local school administrative unit
38 that fails to meet criteria established by the State Board in accordance with this section and the
39 Advanced Teaching Roles designation of any school within that unit. Throughout the program,
40 a local school administrative unit shall provide any information or access requested by (i) the
41 State Board of Education or (ii) the independent research organization selected by the State Board
42 of Education to evaluate the program pursuant to this section.

43 (g) Term; Use of Grant Funds. – Any funds awarded to a local school administrative unit
44 pursuant to this section shall be subject to availability and awarded for a term of up to three years,
45 in the discretion of the State Board. A local school administrative unit shall not be eligible to
46 receive funding for more than one term. Funds awarded to local school administrative units shall
47 be used for any of the following:

48 (1) Development of advanced teaching role plans.

49 (2) Development of professional development courses for teachers in advanced
50 teaching roles that lead to improved student outcomes.

1 (3) Transition costs associated with designing and implementing advanced
2 teaching role models. Transition costs may include employing staff members
3 or contractors to assist with design and implementation of the plan.

4 (4) Development of the design and implementation of compensation plans that
5 focus on teacher professional growth and student outcomes and the transition
6 costs associated with designing and implementing new compensation plans,
7 including employing staff members or contractors to assist with design and
8 implementation of the plan.

9 (h) Program Evaluation. – The State Board of Education shall evaluate how the advanced
10 teaching roles and new compensation plans have accomplished, at a minimum, the following:

11 (1) Improvement in the quality of classroom instruction and increases in
12 school-wide growth or the growth of teachers who are mentored or impacted
13 by a teacher in an advanced teaching role.

14 (2) An increase in the attractiveness of teaching.

15 (3) Recognition, impact, and retention of high-quality classroom teachers.

16 (4) Assistance to and retention of beginning classroom teachers.

17 (5) Improvement in and expansion of the use of technology and digital learning.

18 (6) Improvement in school culture based on school climate survey results.

19 The State Board shall contract with an independent research organization to perform this
20 evaluation in the first two years of the program and provide reports on October 15, 2021, and
21 October 15, 2022. Beginning October 15, 2023, and annually thereafter, the State Board shall
22 perform the evaluation and provide the report. The State Board shall provide any report required
23 in accordance with this subsection to the offices of the President Pro Tempore of the Senate and
24 the Speaker of the House of Representatives, the Senate Appropriations/Base Budget Committee,
25 the House Committee on Appropriations, the Senate Appropriations Committee on
26 Education/Higher Education, the House Appropriations Committee on Education, the Fiscal
27 Research Division, and the Joint Legislative Education Oversight Committee.

28 (i) Class Size Flexibility. – Notwithstanding G.S. 115C-301, with the approval of the
29 State Board of Education, Advanced Teaching Roles schools selected to participate in the
30 program may exceed the maximum class size requirements for kindergarten through third grade
31 during the term of up to three years in which State funds are awarded to the local school
32 administrative unit where the school is located. At the conclusion of the term, any class size
33 flexibility approved for an Advanced Teaching Roles school pursuant to this subsection shall
34 expire.

35 (j) Budget Flexibility. – Subject to the budget flexibility limitations identified in
36 G.S. 115C-105.25(b), the State Board of Education shall authorize local boards of education
37 participating in the program to use any available State funds to provide salary supplements to
38 classroom teachers in an advanced teaching role as long as the local school administrative unit
39 complies with policies of the State Board of Education, federal law, and any State programs with
40 specific restrictions on the use of funds, including bonus and grant programs."

41 **SECTION 2.6.(c)** G.S. 115C-105.25(e) reads as rewritten:

42 "(e) No later than December 1 of each year, the Department of Public Instruction shall
43 collect the information reported by local school administrative units pursuant to subsection (c)
44 of this section and report the aggregated information, including available data from the two
45 previous fiscal years, to the Joint Legislative Education Oversight Committee and the Fiscal
46 Research Division. The report shall also include information on the use of the budget flexibility
47 provided to Advanced Teaching Roles schools pursuant to G.S. 115C-311(j)."

49 **PART III. THE UNIVERSITY OF NORTH CAROLINA SYSTEM**

51 **UNC REPORT ON STATE BUDGET ALLOCATIONS AND POLICIES**

1 **SECTION 3.1.** G.S. 116-11 is amended by adding the following new subdivision to
2 read:

- 3 "(9b) The Board of Governors shall report by February 1 of each year to the Joint
4 Legislative Education Oversight Committee, the Senate Appropriations
5 Committee on Education/Higher Education, the House of Representatives
6 Appropriations Subcommittee on Education, and the Fiscal Research Division
7 on the actions and adjustments necessary to its budgetary policies, regulations,
8 and standards resulting from the Current Operations Appropriations Act for
9 the administration and operation of The University of North Carolina and the
10 distribution of State and federal funds to constituent institutions. The report
11 shall include at least the following information for each constituent institution:
12 a. Guidelines related to State salaries of University of North Carolina
13 employees, including range, median, and mean of faculty salaries at
14 the institution.
15 b. Budget allocations and reductions, including for operating expenses
16 and specific programs.
17 c. Distribution of additional State allocations for enrollment funding.
18 d. Use of State funds and budget flexibility.
19 e. Availability of federal funds.
20 f. Tuition and fees.
21 g. Composition of the student population at the institution, including
22 headcount enrollment and full-time student enrollment for both
23 undergraduate and graduate students, and aggregate data on residency
24 status, median household income, gender, race, and ethnicity.
25 h. Student retention and graduation rates.
26 i. Postsecondary educational attainment rate at the institution, including
27 comparison to statewide data.
28 j. A comparison to prior fiscal year expenditures and appropriations."

29
30 **UNC SYSTEM OFFICE/CREATE SEARCHABLE DATABASE OF MILITARY**

20 percent (15%) cap on the number of Special Assistance in-home payments, as the Secretary
21 deems necessary.

32 **SECTION 4B.2.(a)** If House Bill 1023 of the 2019 Regular Session becomes law,

14 **SECTION 4D.2.** The Department of Health and Human Services (Department) shall
15 issue Medicaid identification cards to recipients on an annual basis with updates as needed. The
16 Department shall adopt rules, or amend any current rules relating to Medicaid identification
17 cards, to implement this section. No later than February 1, 2021, the Department shall submit a
18 report to the Joint Legislative Oversight Committee on Medicaid and NC Health Choice
19 confirming the adoption or amendment of rules in accordance with this section.
20

21 VOLUME PURCHASE PLANS AND SINGLE SOURCE PROCUREMENT

22 **SECTION 4D.3.** The Department of Health and Human Services, Division of Health
23 Benefits, may, subject to the approval of a change in the State Medicaid Plan, contract for
24 services, medical equipment, supplies, and appliances by implementation of volume purchase
25 plans, single source procurement, or other contracting processes in order to improve cost
26 containment.

28 LME/MCO OUT-OF-NETWORK AGREEMENTS

29 **SECTION 4D.4.(a)** Effective until coverage under tailored plans described under
30 G.S. 108D-60 begins, the Department of Health and Human Services shall ensure that local
31 management entities/managed care organizations (LME/MCOs) utilize out-of-network
32 agreements between a single provider of behavioral health or intellectual and developmental
33 disability (IDD) services and the LME/MCO to ensure access to care in accordance with 42
34 C.F.R. § 438.206(b)(4). These out-of-network agreements shall contain standardized elements
35 developed in consultation with all LME/MCOs, reduce administrative burden on providers of
36 behavioral health and IDD services, and comply with all requirements of State and federal laws.
37

38 **SECTION 4D.4(b)** LME/MCOs shall use an out-of-network agreement in lieu of a
comprehensive provider contract when all of the following conditions are met:

- 39 (1) The services requested are medically necessary and cannot be provided by a
40 provider in the LME/MCO's closed provider network.
- 41 (2) The behavioral health or IDD services provider's site of service delivery is
42 located outside of the geographical catchment area of the LME/MCO, and
43 either (i) the LME/MCO is not accepting applications for membership into its
44 closed provider network or (ii) the provider does not wish to apply for
45 membership in the LME/MCO's closed provider network.
- 46 (3) The behavioral health or IDD services provider is not excluded from
47 participation in the Medicaid program, the NC Health Choice program, or any
48 other State or federal health care program.
- 49 (4) The behavioral health or IDD provider is serving no more than two enrollees
50 of the LME/MCO.

1 **SECTION 4D.4.(c)** An LME/MCO shall not restrict its number of out-of-network
 2 agreements to provide inpatient hospitalization services unless the services could be provided by
 3 a provider in the LME/MCO's closed provider network and the out-of-network provider is
 4 unwilling to enter into a network agreement with the LME/MCO.

5 **SECTION 4D.4.(d)** An LME/MCO shall not restrict its number of out-of-network
 6 agreements for other behavioral health and IDD services to foster children and "independent
 7 foster care adolescents," ages 18, 19, and 20, as defined in 42 U.S.C. § 1396d(w)(1) if the person
 8 is already receiving such services from such provider, though the services could be provided by
 9 a provider in the LME/MCO's closed provider network.

10 **SECTION 4D.4.(e)** Any provider enrolled in the North Carolina Medicaid program
 11 that provides services pursuant to an out-of-network agreement shall be considered a network
 12 provider for purposes of Chapter 108D of the General Statutes only as it relates to enrollee
 13 grievances and appeals for those services.

14 **SECTION 4D.4.(f)** This section is effective when it becomes law.

15
 16 **LME/MCO INTERGOVERNMENTAL TRANSFERS**

17 **SECTION 4D.5.(a)** The local management entities/managed care organizations
 18 (LME/MCOs) shall make intergovernmental transfers to the Department of Health and Human
 19 Services, Division of Health Benefits (DHB), in an aggregate amount of eighteen million
 20 twenty-eight thousand two hundred seventeen dollars (\$18,028,217) for the 2020-2021 fiscal
 21 year. The due date and frequency of the intergovernmental transfers required by this section shall
 22 be determined by DHB. The amount of the intergovernmental transfer that each individual
 23 LME/MCO is required to make in the 2020-2021 fiscal year shall be as follows:

31 **SECTION 4D.5.(b)** In the event that any county disengages from an LME/MCO and
 32 realigns with another LME/MCO during the 2019-2021 fiscal biennium, DHB shall have the
 33 authority to reallocate the amount of the intergovernmental transfer that each affected
 34 LME/MCO is required to make under subsection (a) of this section, taking into consideration the
 35 change in catchment area and covered population, provided that the aggregate amount of the
 36 transfers received from all LME/MCOs in each year of the fiscal biennium are achieved.

37 **SECTION 4D.5.(c)** If DHB does not make the additional capitation payment
 38 associated with the Medicaid risk reserve to an LME/MCO in any given month, then the
 39 intergovernmental transfer required to be made by that LME/MCO under subsection (a) of this
 40 section shall be reduced on a pro rata basis and the aggregate amount to be collected by DHB in
 41 the corresponding fiscal year shall be adjusted accordingly.

 46 **FUNDS FOR LOCAL INPATIENT PSYCHIATRIC BEDS OR BED DAYS**

47 **SECTION 4E.1.** Reporting by Department. – By no later than December 1, 2020,
 48 and by no later than December 1, 2021, the Department shall report to the Joint Legislative
 49 Oversight Committee on Health and Human Services and the Fiscal Research Division on all of
 50 the following:

- 1 (1) A uniform system for beds or bed days purchased during the preceding fiscal
 2 year from (i) funds appropriated to the Department for the 2019-2021 fiscal
 3 biennium under S.L. 2019-242 and Section 11F.3 of S.L. 2017-57 that are
 4 designated for this purpose, (ii) existing State appropriations, and (iii) local
 5 funds.
- 6 (2) An explanation of the process used by the Department to ensure that, except
 7 as otherwise provided in Section 11F.3 of S.L. 2017-57, local inpatient
 8 psychiatric beds or bed days purchased in accordance with this section are
 9 utilized solely for individuals who are medically indigent, along with the
 10 number of medically indigent individuals served by the purchase of these beds
 11 or bed days.
- 12 (3) The amount of funds used to pay for facility-based crisis services, along with
 13 the number of individuals who received these services and the outcomes for
 14 each individual.
- 15 (4) The amount of funds used to pay for nonhospital detoxification services, along
 16 with the number of individuals who received these services and the outcomes
 17 for each individual.
- 18 (5) Other Department initiatives funded by State appropriations to reduce State
 19 psychiatric hospital use.

20
 21 **REPORT ON USE OF FUNDS TO PURCHASE INPATIENT ALCOHOL AND**
 22 **SUBSTANCE USE DISORDER TREATMENT SERVICES**

23 **SECTION 4E.2.** The Department of Health and Human Services, Division of Mental
 24 Health, Developmental Disabilities, and Substance Abuse Services, shall report annually,
 25 beginning September 1, 2020, and ending on September 1, 2026, on the implementation of the
 26 use of funds to purchase inpatient alcohol and substance use disorder treatment services required
 27 by Section 12F.12 of S.L. 2015-241, as amended by Section 11F.4 of S.L. 2017-57. The report
 28 shall be submitted to the Joint Legislative Oversight Committee on Health and Human Services
 29 and the Fiscal Research Division with the following information for the prior fiscal year and the
 30 two preceding fiscal years, for each Alcohol and Drug Abuse Treatment Center (ADATC):

- 31 (1) The number of beds in operation.
 32 (2) The number of bed days.
 33 (3) The total amount of receipts, the amount of those receipts that were received
 34 from local management entities/managed care organizations, and the amount
 35 of those receipts that were received from all other sources.
 36 (4) Cost of operation of the ADATC, with personnel and staffing costs reported
 37 separately from all other costs.
 38 (5) The ADATC's profit or loss.

 40 **PART IV-F. PUBLIC HEALTH**

 42 **EXPAND COMPOSITION OF CHILD FATALITY TASK FORCE**

43 **SECTION 4F.1.(a)** G.S. 7B-1402 reads as rewritten:

44 **"§ 7B-1402. Task Force – creation; membership; vacancies.**

45 (a) There is created the North Carolina Child Fatality Task Force within the Department
 46 of Health and Human Services for budgetary purposes only.

47 (b) The Task Force shall be composed of ~~35~~36 members, ~~4~~12 of whom shall be ex
 48 officio members, four of whom shall be appointed by the Governor, 10 of whom shall be
 49 appointed by the Speaker of the House of Representatives, and 10 of whom shall be appointed

- 10 (1) Transitional Living Services, which is an outcome-based program that follows
11 the Youth Villages Transitional Living Model. Outcomes on more than 7,000
12 participants have been tracked since the program's inception. The program has
13 been evaluated through an independent randomized controlled trial. Results
14 indicate that the Youth Villages Transitional Living Model had positive
15 impacts in a variety of areas, including housing stability, earnings, economic
16 hardship, mental health, and intimate partner violence in comparison to the
17 control population.
- 18 (2) Public-Private Partnership, which is a commitment by private-sector funding
19 partners to match at least twenty-five percent (25%) of the funds appropriated
20 to the Foster Care Transitional Living Initiative Fund for the 2019-2021 fiscal
21 biennium for the purposes of providing Transitional Living Services through
22 the Youth Villages Transitional Living Model to youth aging out of foster
23 care.
- 24 (3) Impact Measurement and Evaluation, which are services funded through
25 private partners to provide independent measurement and evaluation of the

26 with the clerk of the Court of Appeals as a part of the record; if not returned with objections
27 within the time prescribed, it shall be deemed approved. The ~~chairman~~ chair of the Industrial
28 Commission shall have the power, in the exercise of ~~his~~ the chair's discretion, to enlarge the time

13 communities or military installations for actual project expenses. Grant funds
14 shall not be used to pay for lobbying the General Assembly, salaries, travel,
15 or other administrative costs. The North Carolina Military Affairs
16 Commission shall establish guidelines for applying for these grants.
17 (2) Administrative expenses and reimbursements for members of the North
18 Carolina Military Affairs Commission.
19 (3) Federal advocacy and lobbying support.
20 (4) Updates to strategic planning analysis and strategic plan.
21 (5) Economic impact analyses.
22 (6) Public-public/public-private (P4) initiatives.
23 (7) Identification and implementation of innovative measures to increase the
24 military value of installations.
25 (8) Fully fund a position at the North Carolina Economic Development Center.

26 (c) The North Carolina Military Affairs Commission shall report to the Joint Legislative
27 Oversight Committee on General Government no later than February 15 of each year on
28 expenditures from the Military Presence Stabilization Fund."

29 **SECTION 17.1.(b)** The Department of Military and Veterans Affairs shall pay
30 expenses authorized by this section and approved by the North Carolina Military Affairs
31 Commission within 30 days of receiving a request from the Commission that payment be made.
32 Notwithstanding the 30-day time period provided for in this subsection, the Department shall
33 make payment on a contract or grant awarded by the Commission no later than the date payment
34 is due according to the terms of the contract or grant, and the Commission shall not be required
35 to request that the Department make the contract or grant payment. The chair may authorize a

 34 **ESTABLISH NORTH CAROLINA VETERANS CEMETERY TRUST FUND**

35 **SECTION 17.4.(a)** There is established the North Carolina Veterans Cemeteries
 36 Trust Fund (hereinafter "Fund"), a special fund within the Department of Military and Veterans
 37 Affairs. The Fund shall be maintained as a special fund and shall be administered by the
 38 Department to carry out the provisions of this section. Interest accruing from the monies in the
 39 Fund shall be credited to the Fund. The Fund shall consist of the following sources of funding:

The funds in the account may be expended only for e-commerce initiatives and projects approved by the State Chief Information Officer, ~~in consultation with the Joint Legislative Oversight Committee on Information Technology. Officer.~~ For purposes of this subsection, the term "public agencies" does not include a county, unit, special district, or other political subdivision of government. The State Chief Information Officer shall report any fees imposed under subsection (b) of this section and expenditures for e-commerce initiatives and projects to the Joint Legislative Commission on Governmental Operations and the Joint Legislative Oversight Committee on Information Technology.

(d) This section does not apply to the Judicial Department."

SECTION 19.1.(b) G.S. 147-86.22 reads as rewritten:**"§ 147-86.22. Statewide accounts receivable program.**

(b) Electronic Payment. – Notwithstanding the provisions of G.S. 147-86.20 and G.S. 147-86.21, this subsection applies to debts owed a community college, a local school administrative unit, an area mental health, developmental disabilities, and substance abuse authority, and the Administrative Office of the Courts, and to debts payable to or through the

1 office of a clerk of superior court or a magistrate, as well as to debts owed to other State agencies
2 as defined in G.S. 147-86.20.

3 The State Controller shall establish policies that allow accounts receivable to be payable
4 under certain conditions by electronic payment. These policies shall be established with the
5 concurrence of the State Treasurer. In addition, any policies that apply to debts payable to or
6 through the office of a clerk of superior court or a magistrate shall be established with the
7 concurrence of the Administrative Officer of the Courts. The Administrative Officer of the Courts
8 may also establish policies otherwise authorized by law that apply to these debts as long as those
