37 **SECTION 2.** There is appropriated from the General Fund to the Administrative
38 Office of the Courts the sum of one hundred thirty-seven thousand seventy-eight dollars
39 (\$137,078) in recurring funds for each fiscal year of the 2021-2023 fiscal biennium and six
40 thousand fifty-six dollars (\$6,056) in nonrecurring funds for the 2021-2022 fiscal year to be used
41 to hire two additional magistrates to serve in Mecklenburg County pursuant to Section 1 of this
42 act.

43 **SECTION 3.** This act becomes effective July 1, 2021.
