Short Title: The SAVE Act. (Public)

2 AN ACT TO DELIVER SAFE, ACCESSIBLE, VALUE-DIRECTED, AND EXCELLENT
3 (SAVE) HEALTH CARE THROUGHOUT NORTH CAROLINA BY MODERNIZING
4 NURSING REGULATIONS.

5 The General Assembly of North Carolina enacts:

6 SECTION 1. G.S. 90-171.20 reads as rewritten:

7 "§ 90-171.20. Definitions.

8 As used in this Article, unless the context requires otherwise:

9 (1) Advanced assessment. – The taking by an advanced practice registered nurse
10 of the history, physical, and psychological assessment of a patient's signs,
11 symptoms, pathophysiologic status, and psychosocial variations in the
12 determination of differential diagnoses and treatment.

13 (1a) Advanced practice registered nurse or APRN. – An individual licensed by the
14 Board as an advanced practice registered nurse within one of the following
15 four roles:

- 16 a. Nurse practitioner or NP.
17 b. Certified nurse midwife or CNM.
18 c. Clinical nurse specialist or CNS.
19 d. Certified registered nurse anesthetist or CRNA.

20 (1b) ~~"Board" means the Board.~~ – The North Carolina Board of Nursing.

21 (2) ~~"Health care provider" means any Health care provider.~~ – Any licensed health
22 care professional and any agent or employee of any health care institution,
23 health care insurer, health care professional school, or a member of any allied
24 health profession. For purposes of this Article, a person enrolled in a program
25 that prepares the person to be a licensed health care professional or an allied
26 health professional shall be deemed a health care provider.

27 (3) ~~"License" means a License.~~ – A permit issued by the Board to practice nursing
28 as an advanced practice registered nurse, as a registered nurse-nurse, or as a
29 licensed practical nurse, including a renewal or reinstatement thereof.

30 (3a) ~~"Licensee" means any Licensee.~~ – Any person issued a license by the Board,
31 whether the license is active or inactive, including an inactive license by
32 means of surrender.

33 (4) ~~"Nursing" is a Nursing.~~ – A dynamic discipline which includes the assessing,
34 caring, counseling, teaching, referring and implementing of prescribed
35 treatment in the maintenance of health, prevention and management of illness,
36 injury, disability or the achievement of a dignified death. It is ministering to;



1 assisting; and sustained, vigilant, and continuous care of those acutely or
2 chronically ill; supervising patients during convalescence and rehabilitation;
3 the supportive and restorative care given to maintain the optimum health level
4 of individuals, groups, and communities; the supervision, teaching, and
5 evaluation of those who perform or are preparing to perform these functions;
6 and the administration of nursing programs and nursing services. For purposes
7 of this Article, the administration of required lethal substances or any
8 assistance whatsoever rendered with an execution under Article 19 of Chapter
9 15 of the General Statutes does not constitute nursing.

10 (5) ~~"Nursing program" means any~~ Nursing program. – Any educational program
11 in North Carolina offering to prepare persons to meet the educational
12 requirements for licensure under this Article. ~~Article as a registered nurse or a~~
13 licensed practical nurse.

14 (6) ~~"Person" means an~~ Person. – An individual, corporation, partnership,
15 association, unit of government, or other legal entity.

16 (6a) Population focus. – With respect to APRN practice, includes one of the
17 following areas of focus:

18 a. The family or the individual across the life span.

19 b. Adult/gerontology.

20 c. Neonatal.

21 d. Pediatrics.

22 e. Women's health or gender-related issues.

23 f. Psychiatric mental health.

24 (6b) Practice of nursing as an advanced practice registered nurse or APRN. – In
25 addition to the RN scope of practice and within the APRN role and population
26 foci, also consists of the following six components:

27 a. Conducting an advanced assessment.

28 b. Delegating and assigning therapeutic measures to assistive personnel.

29 c. Performing other acts that require education and training consistent
30 with professional standards and commensurate with the APRN's
31 education, certification, demonstrated competencies, and experience.

32 d. Complying with the requirements of this Article and rendering quality
33 advanced nursing care.

34 e. Recognizing limits of knowledge and experience.

35 f. Planning for the management of situations beyond the APRN's
36 expertise.

37 (6c) Practice of nursing as a certified nurse midwife or CNM. – In addition to the
38 RN scope of practice and APRN role and population foci, also consists of the
39 following four components:

40 a. The management, diagnosis, and treatment of primary sexual and
41 reproductive health care, including primary, preconception,
42 gynecologic/reproductive/sexual health, antepartum, intrapartum,
43 neonatal, and post-pregnancy care.

44 b. Ordering, performing, supervising, and interpreting diagnostic studies.

45 c. Prescribing pharmacologic and nonpharmacologic therapies.

46 d. Consulting with or referring to other health care providers as
47 warranted by the needs of the patient.

48 (6d) Practice of nursing as a certified registered nurse anesthetist or CRNA. – In
49 addition to the RN scope of practice and within the APRN role and population
50 foci, also consists of the following:

- 1 a. Selecting, ordering, procuring, prescribing, and administering drugs
2 and therapeutic devices to facilitate diagnostic, therapeutic, and
3 surgical procedures.
- 4 b. Ordering, prescribing, performing, supervising, and interpreting
5 diagnostic studies, procedures, and interventions.
- 6 c. Consulting with or referring to other health care providers as
7 warranted by the needs of the patient.
- 8 (6e) Practice of nursing as a clinical nurse specialist or CNS. – In addition to the
9 RN scope of practice and APRN role and population foci, also consists of the
10 following eight components:
- 11 a. The diagnosis and treatment of health and illness states.
12 b. Disease management.
13 c. Prescribing pharmacologic and nonpharmacologic therapies.
14 d. Ordering, performing, supervising, and interpreting diagnostic studies.
15 e. Preventing of illness and risk behaviors.
16 f. Nursing care for individuals, families, and communities.
17 g. Integrating care across the continuum to improve patient outcomes.
18 h. Consulting with or referring to other health care providers as
19 warranted by the needs of the patient.
- 20 (6f) Practice of nursing as a nurse practitioner or NP. – In addition to the RN scope
21 of practice and APRN role and population foci, also consists of the following
22 six components:
- 23 a. Health promotion, disease prevention, health education, and
24 counseling.
- 25 b. Providing health assessment and screening activities.
26 c. Diagnosing, treating, and facilitating patients' management of their
27 acute and chronic illnesses and diseases.
- 28 d. Ordering, performing, supervising, and interpreting diagnostic studies.
29 e. Prescribing pharmacologic and nonpharmacologic therapies.
30 f. Consulting with or referring to other health care providers as
31 warranted by the needs of the patient.
- 32 (7) ~~The "practice of nursing by a registered nurse" consists~~ Practice of nursing by
33 a registered nurse. – Consists of the following 10 components:
- 34 a. Assessing the patient's physical and mental health, including the
35 patient's reaction to illnesses and treatment regimens.
- 36 b. Recording and reporting the results of the nursing assessment.
- 37 c. Planning, initiating, delivering, and evaluating appropriate nursing
38 acts.
- 39 d. Teaching, assigning, delegating to or supervising other personnel in
40 implementing the treatment regimen.
- 41 e. Collaborating with other health care providers in determining the
42 appropriate health care for a patient ~~but, subject to the provisions of~~
43 ~~G.S. 90-18.2, not prescribing a medical treatment regimen or making~~
44 ~~a medical diagnosis, except under supervision of a licensed~~
45 ~~physician-patient.~~
- 46 f. Implementing the treatment and pharmaceutical regimen prescribed or
47 ordered by any person authorized by State law to prescribe or order
48 the regimen.
- 49 g. Providing teaching and counseling about the patient's health.
- 50 h. Reporting and recording the plan for care, nursing care given, and the
51 patient's response to that care.

- i. Supervising, teaching, and evaluating those who perform or are preparing to perform nursing functions and administering nursing programs and nursing services.
 - j. Providing for the maintenance of safe and effective nursing care, whether rendered directly or indirectly.
- (8) ~~The "practice of nursing by a licensed practical nurse" consists~~ Practice of nursing by a licensed practical nurse. – Consists of the following seven components:
- a. Participating in the assessment of the patient's physical and mental health, including the patient's reaction to illnesses and treatment regimens.
 - b. Recording and reporting the results of the nursing assessment.
 - c. Participating in implementing the health care plan developed by the registered nurse and/or prescribed by any person authorized by State law to prescribe such a plan, by performing tasks assigned or delegated by and performed under the supervision or under orders or directions of a registered nurse, physician licensed to practice medicine, dentist, or other person authorized by State law to provide the supervision.
 - c1. Assigning or delegating nursing interventions to other qualified personnel under the supervision of the registered nurse.
 - d. Participating in the teaching and counseling of patients as assigned by a registered nurse, physician, or other qualified professional licensed to practice in North Carolina.
 - e. Reporting and recording the nursing care rendered and the patient's response to that care.
 - f. Maintaining safe and effective nursing care, whether rendered directly or indirectly."

SECTION 2. G.S. 90-18(c) reads as rewritten:

"(c) The following shall not constitute practicing medicine or surgery as defined in this Article:

- ...
- ~~(7) The practice of midwifery as defined in G.S. 90-178.2.~~
- ...
- (14) ~~The practice of nursing by a~~ an advanced practice registered nurse engaged in the practice of nursing and the performance of acts otherwise constituting medical practice by a registered nurse when performed in accordance with rules and regulations developed by a joint subcommittee of the North Carolina Medical Board and the Board of Nursing and adopted by both boards, as defined in Article 9A of this Chapter.

...."

SECTION 3.(a) G.S. 90-18.2 is repealed.

SECTION 3.(b) G.S. 90-2(a) reads as rewritten:

"(a) There is established the North Carolina Medical Board to regulate the practice of medicine and surgery for the benefit and protection of the people of North Carolina. The Board shall consist of 13 members:

- ...
- (2) Five members shall all be appointed by the Governor as follows:
- ...
- d. One shall be a nurse practitioner ~~as defined in G.S. 90-18.2~~ as recommended by the Review Panel pursuant to G.S. 90-3.

...."

SECTION 3.(c) G.S. 90-18.3(a) reads as rewritten:

"(a) Whenever a statute or State agency rule requires that a medical or physical examination shall be conducted by a physician, the examination may be conducted and the form signed by a nurse practitioner or a physician assistant, and a physician need not be present. Nothing in this section shall otherwise change the scope of practice of a nurse practitioner or a physician assistant, as defined by G.S. 90-18.1 and G.S. 90-18.2, respectively.assistant."

SECTION 3.(d) G.S. 90-85.24(a) reads as rewritten:

"(a) The Board of Pharmacy shall be entitled to charge and collect not more than the following fees:

...

(13) For annual registration as a dispensing nurse practitioner under G.S. 90-18.2, practitioner, seventy-five dollars (\$75.00);

...."

SECTION 3.(e) G.S. 90-85.34A reads as rewritten:

"§ 90-85.34A. Public health pharmacy practice.

...

(c) This section does not affect the practice of nurse practitioners pursuant to G.S. 90-18.2 or of physician assistants pursuant to G.S. 90-18.1."

SECTION 4. G.S. 90-29(b) reads as rewritten:

"(b) A person shall be deemed to be practicing dentistry in this State who does, undertakes or attempts to do, or claims the ability to do any one or more of the following acts or things which, for the purposes of this Article, constitute the practice of dentistry:

...

(6) Administers an anesthetic of any kind in the treatment of dental or oral diseases or physical conditions, or in preparation for or incident to any operation within the oral cavity; provided, however, that this subsection shall not apply to a lawfully qualified certified registered nurse anesthetist who administers such anesthetic under the supervision and direction of a licensed dentist or physician;anesthetic.

...."

SECTION 5. G.S. 90-171.23(b) reads as rewritten:

"(b) Duties, powers. The Board is empowered to:

...

(14) ~~Appoint and maintain a subcommittee of the Board to work jointly with the subcommittee of the North Carolina Medical Board to develop rules and regulations to govern the performance of medical acts by registered nurses and to determine reasonable fees to accompany an application for approval or renewal of such approval as provided in G.S. 90-8.2. The fees and rules developed by this subcommittee shall govern the performance of medical acts by registered nurses and shall become effective when they have been adopted by both Boards.~~ Grant prescribing, ordering, dispensing, and furnishing authority to holders of the advanced practice registered nurse license pursuant to G.S. 90-171.20.

...."

SECTION 6. G.S. 90-171.27(b) reads as rewritten:

"§ 90-171.27. Expenses payable from fees collected by Board.

(b) The schedule of fees shall not exceed the following rates:

28 A fee for an item listed in this schedule shall not increase from one year to the next by more
 29 than twenty percent (20%)."

30 **SECTION 7.(a)** Article 9A of Chapter 90 of the General Statutes is amended by
 31 adding the following new sections to read:

32 **"§ 90-171.36B. Advanced practice registered nurse licensure.**

33 (a) No advanced practice registered nurse shall practice as an advanced practice
 34 registered nurse unless the nurse is licensed by the Board under this section.

35 (b) An applicant for a license to practice as an APRN shall apply to the Board in a format
 36 prescribed by the Board and pay a fee in an amount determined under G.S. 90-171.27.

37 (c) The Board shall adopt rules, not inconsistent with this Article, which identify the
 38 criteria which must be met by an applicant in order to be issued a license.

39 **"§ 90-171.36C. Advanced practice registered nurse licensure; grandfathering exceptions.**

40 (a) The Board shall issue an APRN license to any person recognized by the Board as an
 41 APRN or approved to practice as an APRN in this State on December 31, 2021.

42 (b) An advanced practice registered nurse licensed under this section shall maintain all
 43 practice privileges provided to licensed advanced practice registered nurses under this Chapter.

44 **"§ 90-171.36D. Advanced practice registered nurse licensure renewal; reinstatement.**

45 (a) An applicant for renewal of an APRN license issued under this Article shall apply for
 46 licensure renewal according to the frequency and schedule established by the Board and pay the
 47 required fee.

48 (b) Failure to renew the APRN license before the expiration date shall result in automatic
 49 forfeiture of the right to practice nursing as an APRN in North Carolina until such time as the
 50 license has been reinstated.

1 (c) An APRN licensee who has allowed his or her license to lapse by failure to renew
2 may apply for reinstatement in a manner prescribed by the Board and pay the required fee.

3 (d) The Board shall adopt rules, not inconsistent with this Article, which identify the
4 criteria which must be met by an applicant for APRN license renewal or reinstatement."

5 **SECTION 7.(b)** G.S. 90-171.37(b) is repealed.

6 **SECTION 8.** G.S. 90-171.43 reads as rewritten:

7 **"§ 90-171.43. License required.**

8 (a) No person shall practice or offer to practice as ~~a~~an advanced practice registered nurse,
9 registered nurse-nurse, or licensed practical nurse, or use the word "nurse" as a title for herself or
10 himself, or use an abbreviation to indicate that the person is ~~a~~an advanced practice registered
11 nurse, registered nurse-nurse, or licensed practical nurse, unless the person is currently licensed
12 as ~~a~~an advanced practice registered nurse, registered nurse-nurse, or licensed practical nurse as
13 provided by this Article. If the word "nurse" is part of a longer title, such as "nurse's aide", a
14 person who is entitled to use that title shall use the entire title and may not abbreviate the title to
15 "nurse". This Article shall not, however, be construed to prohibit or limit the following:

16 (1) The performance by any person of any act for which that person holds a
17 license issued pursuant to North Carolina ~~law;~~law.

18 (2) The clinical practice by students enrolled in approved nursing programs,
19 continuing education programs, or refresher courses under the supervision of
20 qualified ~~faculty;~~faculty.

21 (3) The performance of nursing performed by persons who hold a temporary
22 license issued pursuant to ~~G.S. 90-171.33;~~G.S. 90-171.33.

23 (4) The delegation to any person, including a member of the patient's family, by
24 a physician licensed to practice medicine in North Carolina, a licensed dentist
25 or registered nurse of those patient-care services which are routine, repetitive,
26 limited in scope that do not require the professional judgment of a registered
27 nurse or licensed practical ~~nurse;~~nurse.

28 (5) Assistance by any person in the case of emergency.

29 Any person permitted to practice nursing without a license as provided in subdivision ~~{(a)}(2)~~
30 ~~(a)(2) or {(a)}(3)-(a)(3)~~ of this section shall be held to the same standard of care as any licensed
31 nurse.

32 (a1) The abbreviations for the APRN designation of a certified nurse midwife, a clinical
33 nurse specialist, a certified registered nurse anesthetist, and a nurse practitioner shall be APRN,
34 plus the role title, i.e., CNM, CNS, CRNA, and NP.

35 (a2) It shall be unlawful for any person to use the title "APRN" or "APRN" plus their
36 respective role titles, the role title alone, authorized abbreviations, or any other title that would
37 lead a person to believe the individual is an APRN, unless permitted by this act.

38"

39 **SECTION 9.** G.S. 90-171.43A reads as rewritten:

40 **"§ 90-171.43A. Mandatory employer verification of licensure status.**

41 (a) Before hiring an advanced practice registered nurse, a registered ~~nurse-nurse,~~ or a
42 licensed practical nurse in North Carolina, a health care facility shall verify that the applicant has
43 a current, valid license to practice nursing pursuant to G.S. 90-171.43.

44 (b) For purposes of this section, "health care facility" means:

45 (1) Facilities described in G.S. 131E-256(b).

46 (2) Public health departments, physicians' offices, ambulatory care facilities, and
47 rural health clinics."

48 **SECTION 10.** G.S. 90-171.44 reads as rewritten:

49 **"§ 90-171.44. Prohibited acts.**

50 It shall be a violation of this Article, and subject to action under G.S. 90-171.37, for any
51 person to:

- 1 (1) Sell, fraudulently obtain, or fraudulently furnish any nursing diploma or aid
- 2 or abet therein.
- 3 (2) Practice nursing under cover of any fraudulently obtained license.
- 4 (3) Practice nursing without a license. This subdivision shall not be construed to
- 5 prohibit any licensed registered nurse who has successfully completed a
- 6 program established under G.S. 90-171.38(b) from conducting medical
- 7 examinations or performing procedures to collect evidence from the victims
- 8 of offenses described in that subsection.
- 9 (3a) Refer to himself or herself as an advanced practice registered nurse; or refer
- 10 to himself or herself as any of the four roles of advanced practice registered
- 11 nurses, a registered nurse, or a licensed practical nurse; or use the
- 12 abbreviations "APRN," "CNM," "CNS," "CRNA," "NP," "RN," and "LPN."
- 13 (4) Conduct a nursing program or a refresher course for activation of a license,
- 14 that is not approved by the Board.
- 15 (5) Employ unlicensed persons to practice nursing."

16 **SECTION 11.(a)** Article 10A of Chapter 90 of the General Statutes is repealed.

17 **SECTION 11.(b)** G.S. 90-21.11 reads as rewritten:

18 **"§ 90-21.11. Definitions.**

19 The following definitions apply in this Article:

- 20 (1) Health care provider. – Without limitation, any of the following:
- 21 a. A person who pursuant to the provisions of Chapter 90 of the General
- 22 Statutes is licensed, or is otherwise registered or certified to engage in
- 23 the practice of or otherwise performs duties associated with any of the
- 24 following: medicine, surgery, dentistry, pharmacy, optometry,
- 25 ~~midwifery~~, osteopathy, podiatry, chiropractic, radiology, nursing,
- 26 physiotherapy, pathology, anesthesiology, anesthesia, laboratory
- 27 analysis, rendering assistance to a physician, dental hygiene,
- 28 psychiatry, or psychology.

29 "...."

30 **SECTION 12.(a)** No later than 30 calendar days after this act becomes law, the
31 Governor shall submit to the Centers for Medicare and Medicaid Services an "opt-out" letter
32 requesting an exemption under 42 C.F.R. § 482.52(c) that allows hospitals, ambulatory surgical
33 centers, critical access hospitals, and rural hospitals in this State the maximum flexibility to
34 obtain Medicare reimbursement for anesthesia services in a manner that best serves each facility
35 and the patients and communities the facility serves.

36 **SECTION 12.(b)** This section is effective when it becomes law.

37 **SECTION 13.(a)** The North Carolina Board of Nursing, the North Carolina Medical
38 Board, and the North Carolina State Board of Dental Examiners shall adopt rules to implement
39 the provisions of this act.

40 **SECTION 13.(b)** This section is effective when it becomes law.

41 **SECTION 14.** This act becomes effective October 1, 2021.
