2 AN ACT TO APPOINT PERSONS TO VARIOUS PUBLIC OFFICES UPON THE
3 RECOMMENDATION OF THE SPEAKER OF THE HOUSE OF REPRESENTATIVES
4 AND THE PRESIDENT PRO TEMPORE OF THE SENATE.

5 Whereas, G.S. 120-121 authorizes the General Assembly to make certain
6 appointments to public offices upon the recommendation of the Speaker of the House of
7 Representatives and the President Pro Tempore of the Senate; and

8 Whereas, the Speaker of the House of Representatives and the President Pro Tempore
9 of the Senate have made recommendations; Now, therefore,
10 The General Assembly of North Carolina enacts:

12 **PART I. SPEAKER'S RECOMMENDATIONS**

13 **SECTION 1.1.** Chief John T. Cole of Alamance County is appointed to the 911
14 Board for a term expiring on December 31, 2022, to fill the unexpired term of Cecil V. "Buddy"
15 Martinette, Jr.

16 **SECTION 1.2.** Dr. Scott A. Playford of Onslow County is appointed to the Boxing
17 Advisory Commission for a term expiring on June 30, 2023.

18 **SECTION 1.3.(a)** Dr. Edward C. Jauch of Buncombe County is appointed to the
19 North Carolina Brain Injury Advisory Council for a term expiring on September 30, 2023, to fill
20 the unexpired term of Dr. Ryan Lamb.

21 **SECTION 1.3.(b)** Todd Bennett of Cabarrus County is appointed to the North
22 Carolina Brain Injury Advisory Council for a term expiring on September 30, 2024.

23 **SECTION 1.4.** Effective March 1, 2021, Ricky Parks of Nash County and Hoyt G.
24 Tessener of Wake County are appointed to the Governor's Crime Commission for terms expiring
25 on February 28, 2023.

26 **SECTION 1.5.** Dr. Rocco F. DiSanto of Burke County and Dr. Gerald W. Poplin of
27 Stanly County are appointed to the Information Technology Strategy Board for terms expiring
