HOUSE BILL DRH30201-TC-15

Short Title: Delay CMS Board Elections/Census Delay. (Local)

1 A BILL TO BE ENTITLED  
2 AN ACT TO AUTHORIZE THE DELAY OF THE 2021 ELECTIONS FOR THE  
3 CHARLOTTE-MECKLENBURG BOARD OF EDUCATION IF CENSUS DATA IS NOT  
4 AVAILABLE TO THE BOARD OF EDUCATION BY A DATE CERTAIN.  
5 The General Assembly of North Carolina enacts:  
6 **SECTION 1.** Notwithstanding S.L. 1993-167, elections to the  
7 Charlotte-Mecklenburg Board of Education shall not be held in 2021. Members elected to the  
8 Charlotte-Mecklenburg Board of Education in 2017, or persons filling vacancies for those terms,  
9 whose terms were set to expire on December 6, 2021, shall hold over in office until their  
10 successors are elected and qualified. Election for those terms of office shall be held at the time  
11 of the general election for county offices in 2022, with the results determined as provided by  
12 G.S. 163-292. Candidates shall file their notices of candidacy for the election in 2022 with the  
13 Mecklenburg Board of Elections no earlier than 12:00 noon on July 25, 2022, and no later than  
14 12:00 noon on August 12, 2022. Terms of office of members of the Charlotte-Mecklenburg Board  
15 of Education elected in 2022 shall commence on December 6, 2022, and shall expire on  
16 December 2, 2025.  
17 **SECTION 2.** Section 1 of this act shall become effective only if the federal decennial  
18 census information for the 2020 census has not been received by the Charlotte-Mecklenburg  
19 Board of Education by July 19, 2021. If the Charlotte-Mecklenburg Board of Education has not  
20 received notice of the federal decennial census information by July 19, 2021, the Board shall  
21 adopt a resolution to that effect which states that census information was not received and that,  
22 pursuant to this act, the next election for the Charlotte-Mecklenburg Board of Education will  
23 occur at the time of the 2022 general election. The Board of Education shall adopt the resolution  
24 prior to July 26, 2021, and shall publish notice of the delay in the election both on the website of  
25 the Charlotte-Mecklenburg Board of Education and at least once in a newspaper of general  
26 circulation within seven days of adoption of that resolution. The resolution shall also be  
27 submitted to the Mecklenburg Board of Elections and to the State Board of Elections prior to  
28 July 26, 2021.  
29 **SECTION 3.** This act is effective when it becomes law.
