10	Budget Act, Chapter 143C of the General Statutes, shall devise techniques and procedures for		
11	the receipt, deposit, and disbursement of moneys coming into their control and custody which		
12	are designed to maximize interest-bearing investment of cash, and to minimize idle and		
13	nonproductive cash balances. This policy shall apply to the General Court of Justice as defined		
14	in Article IV of the North Carolina Constitution, the public school administrative units, units as		
15	defined in G.S. 147-86.12, and the community colleges with respect to the receipt, deposit, and		
16	disbursement of moneys required by law to be deposited with the State Treasurer and with respect
