The General Assembly of North Carolina enacts: **SECTION 1.** G.S. 97-53 reads as rewritten: "§ 97-53. Occupational diseases enumerated; when due to exposure to chemicals. The following diseases and conditions only shall be deemed to be occupational diseases within the meaning of this Article: Special provisions for employment-related occupational diseases of first (30)responders. – The following provisions apply in determining eligibility of a first responder for compensation benefits under this Article: The term "first responder," as used in this section, means a law a. enforcement officer, a firefighter, a 911 dispatcher, or an emergency medical technician or paramedic employed by State or local government. The term also includes a volunteer firefighter meeting the requirement of G.S. 58-84-5(3a). For the purposes of this section, posttraumatic stress disorder, as b. described in the Diagnostic and Statistical Manual of Mental Disorders, Current Edition, published by the American Psychiatric Association, suffered by a first responder without other injury is a compensable occupational disease that arises out of employment as a first responder and arises out of injuries that are characteristic of and peculiar to a particular trade, occupation, process, or employment if (i) the posttraumatic stress disorder resulted from the first responder
