SENATE BILL DRS45327-MKa-135B

Short Title: HBCU Success Act.

(Public)

Sponsors: Senators Davis, Steinburg, and Lowe (Primary Sponsors).

Referred to:

1 A BILL TO BE ENTITLED  
2 AN ACT TO APPROPRIATE FUNDS FOR VARIOUS CAPITAL PROJECTS TO SUPPORT  
3 CONSTITUENT INSTITUTIONS OF THE UNIVERSITY OF NORTH CAROLINA  
4 DESIGNATED AS HISTORICALLY BLACK COLLEGES AND UNIVERSITIES.

5 The General Assembly of North Carolina enacts:

6 **SECTION 1.(a)** ECSU/Residential Hall. – There is transferred from the General  
7 Fund to the State Capital and Infrastructure Fund the sum of eighty million dollars (\$80,000,000)  
8 in nonrecurring funds for the 2021-2022 fiscal year.

9 **SECTION 1.(b)** There is appropriated from the State Capital and Infrastructure Fund  
10 to the Board of Governors of The University of North Carolina the sum of eighty million dollars  
11 (\$80,000,000) in nonrecurring funds for the 2021-2022 fiscal year to provide funds for the  
12 construction of a new residential hall at Elizabeth City State University.

13 **SECTION 2.(a)** ECSU/Library Replacement. – There is transferred from the  
14 General Fund to the State Capital and Infrastructure Fund the sum of (i) three million two hundred  
15 thousand dollars (\$3,200,000) in nonrecurring funds for the 2021-2022 fiscal year and (ii) eight  
16 million dollars (\$8,000,000) in nonrecurring funds for the 2022-2023 fiscal year.

17 **SECTION 2.(b)** There is appropriated from the State Capital and Infrastructure Fund  
18 to the Board of Governors of The University of North Carolina the sum of (i) three million two  
19 hundred thousand dollars (\$3,200,000) in nonrecurring funds for the 2021-2022 fiscal year and  
20 (ii) eight million dollars (\$8,000,000) in nonrecurring funds for the 2022-2023 fiscal year to  
21 provide funds for the library replacement project at Elizabeth City State University. The total  
22 amount authorized for the project is thirty-two million dollars (\$32,000,000).

23 **SECTION 3.(a)** WSSU/K.R. Williams Auditorium Capital Project. – There is  
24 transferred from the General Fund to the State Capital and Infrastructure Fund the sum of  
25 fifty-seven million dollars (\$57,000,000) in nonrecurring funds for the 2021-2022 fiscal year.

26 **SECTION 3.(b)** There is appropriated from the State Capital and Infrastructure Fund  
27 to the Board of Governors of The University of North Carolina the sum of fifty-seven million  
28 dollars (\$57,000,000) in nonrecurring funds for the 2021-2022 fiscal year to provide funds for  
29 the capital project at K.R. Williams Auditorium at Winston-Salem State University.

30 **SECTION 4.** This act becomes effective July 1, 2021.
