2 AN ACT TO ADDRESS PANDEMIC LEARNING LOSS BY ALLOWING ADDITIONAL
3 ADJUSTMENTS TO THE SCHOOL CALENDAR FOR KANNAPOLIS CITY SCHOOLS
4 AND CABARRUS COUNTY SCHOOLS.

5 The General Assembly of North Carolina enacts:

6 SECTION 1. G.S. 115C-84.2(d) reads as rewritten:

7 "(d) Opening and Closing Dates. – Local boards of education shall determine the dates of
8 opening and closing the public schools under subdivision (a)(1) of this section. Except for
9 year-round schools, the opening date for students shall be no earlier than ~~the Monday closest to~~
10 ~~August 26, August 10,~~ and the closing date for students shall be no later than the Friday closest
11 to June 11. ~~On a showing of good cause, the State Board of Education may waive the requirement~~
12 ~~that the opening date for students be no earlier than the Monday closest to August 26 and may~~
13 ~~allow the local board of education to set an opening date no earlier than the Monday closest to~~
14 ~~August 19, to the extent that school calendars are able to provide sufficient days to accommodate~~
15 ~~anticipated makeup days due to school closings. A local board may revise the scheduled closing~~
16 ~~date if necessary in order to comply with the minimum requirements for instructional days or~~
17 ~~instructional time. For purposes of this subsection, the term "good cause" means that schools in~~
18 ~~any local school administrative unit in a county have been closed eight days per year during any~~
19 ~~four of the last 10 years because of severe weather conditions, energy shortages, power failures,~~
20 ~~or other emergency situations.~~

22 SECTION 2. G.S. 115C-174.12(a)(4) reads as rewritten:

23 "(4) All annual assessments of student achievement adopted by the State Board of
24 Education pursuant to G.S. 115C-174.11(c)(1) and (3) and all final exams for
25 courses shall be administered within the final 10 instructional days of the
26 school year for year-long courses and within the final five instructional days
27 of the semester for semester ~~courses. courses, including fall semesters ending~~
28 ~~prior to December 31.~~ Exceptions shall be permitted to accommodate a
29 student's individualized education program and section 504 (29 U.S.C. § 794)
30 plans and for the administration of final exams for courses with national or
31 international curricula required to be held at designated times."

32 SECTION 3. This act applies only to Kannapolis City Schools and Cabarrus County
33 Schools.

34 SECTION 4. This act is effective when it becomes law and applies beginning with
35 the 2021-2022 school year.
