1 A JOINT RESOLUTION CONFIRMING THE GOVERNOR'S APPOINTMENTS OF  
2 JULIANNA EARP, MARK DAVIS, MICHAEL ROBINSON, AND ADAM CONRAD AS  
3 SPECIAL SUPERIOR COURT JUDGES.

4 Whereas, under the provisions of G.S. 7A-45.1(a10), as special superior court  
5 judgeships become vacant, the Governor shall submit the names of his nominees for those  
6 judgeships to the General Assembly for confirmation by ratified joint resolution; and

7 Whereas, the Governor wishes to appoint Julianna Earp as a special court judge to fill  
8 a vacant term that occurred on January 1, 2021, and to appoint her to a full term; and

9 Whereas, the Governor wishes to appoint Mark Davis and to reappoint Michael  
10 Robinson and Adam Conrad as special superior court judges; and

11 Whereas, the Governor has submitted to the presiding officers of the House of  
12 Representatives and the Senate the names of his nominees for terms as special superior court  
13 judges; Now, therefore,

14 Be it resolved by the House of Representatives, the Senate concurring:

15 **SECTION 1.(a)** The General Assembly confirms the appointment of Julianna Earp  
16 as a special superior court judge, whose term of office shall commence upon confirmation to fill  
17 a vacant term that occurred on January 1, 2021.

18 **SECTION 1.(b)** The General Assembly confirms the appointment of Julianna Earp  
19 as a special superior court judge, whose term of office shall commence on July 1, 2021, and  
20 whose term of office shall end five years from the appointment.

21 **SECTION 2.** The General Assembly confirms the appointment of Mark Davis as a  
22 special superior court judge, whose term of office shall commence on July 1, 2021, and whose  
23 term of office shall end five years from the appointment.

24 **SECTION 3.** The General Assembly confirms the reappointment of Michael  
25 Robinson as a special superior court judge, whose term of office shall commence on July 1, 2021,  
26 and whose term of office shall end five years from the appointment.

27 **SECTION 4.** The General Assembly confirms the reappointment of Adam Conrad  
28 as a special superior court judge, whose term of office shall commence after his term expires on  
29 December 23, 2021, and whose term of office shall end five years from the appointment.

30 **SECTION 5.** This resolution is effective upon ratification.
